- 1. The Government of Mozambique (GoM) hereinafter referred to as "the Borrower" have received the Grant funds from International Development Association (IDA) towards the cost of the Sustainable Energy and Broadband Access in Rural Mozambique Project (PROENERGIA +). The funds have been channeled through the national Power Utility, Electricidade de Moçambique, E.P. (EDM) as the Project Implementation Agency and EDM intends to apply part of the proceeds for consulting services.
- 2. The consulting services ("the Services") includes a Lump-Sum contract for Assistance of EDM on Technical, Legal and Financial Study for Fiber Optic Network Commercialization, whose total estimated level of effort of one project manager, one Telecommunications expert, one Finance or Business Manager Expert, one Transmission Expert and one Legal Advisor is 18.5 Man Months over a period of six months.

- 5. Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
- A Consultant will be selected in accordance with the QCBS Quality and Cost-Base Selection method set out in the Procurement Regulations.
