


## The Norwegian ferry market



• 130 ferry routes and 200 ferries

- 22 mill. vehicles and 44 mill. passengers annually
- Routes operated by private ferry companies, through competitive tendering
- Annual turnover 600 million Euros, 50 % operating subsidies from the government



#### Success criteria/prerequisites

- Involvement and commitment from Norwegian authorities and NPRA management regarding the ambitions and direction of development
- Funding that reflects the level of ambition
- A competent and professional procurement organization that secures cost efficient procurement of ferry services
- Dialogue with the market
- Joint effort from the public procurers in the ferry market (critical mass)
- Consistent and predictable requirements
- Market development
  - Measures to secure the long term development of the ferry market
  - Individual tenders assessment of economic risk on the ferry companies and predictable conditions


