For the period from January to March 2022, Air France and KLM will offer flights between Bangkok and Paris, Amsterdam as below:

- Air France offers **up to 5 weekly flights** between **Bangkok and Paris**. Additional flights are operated on selected Sundays from Bangkok to Paris.
- KLM Royal Dutch Airlines offers daily flights between Bangkok to Amsterdam

#### Air France and KLM Traveldoc Websites

Due to the health situation, some countries require a negative Covid-19 test, quarantine on arrival and special travel documents. These travel requirements are regularly updated. Air France and KLM recommend all customers to check **Air France Traveldoc** and **KLM Traveldoc** sites regularly before the trip.

### Travel requirements to/via France

Customers traveling from Orange Countries, such as Thailand, to France, are required:

- To present a **negative PCR test result** or a **negative antigenic test result** less than **48 hours before departure** (all travelers aged 12 years and above)
- To present a sworn statement certifying the absence of COVID-19 symptoms and of any contact with a confirmed
  case of COVID-19
- To fill a the <u>digital traceability form</u> (dPLF) prior to travel
- To fill the **Eos electronic form**
- To present a certificate of international travel for Metropolitan France (non-vaccinated travelers only)
- To self-isolate for 7 days and to take a COVID-19 PCR test at the end of the isolation period (non-vaccinated travelers only)

Customers transferring in Paris-Charles de Gaulle Airport do not need to present negative COVID-19 NAAT (PCR) test result but if required by final destination.

#### Travel requirements to/via The Netherlands

Customers aged 12 years and above traveling from a country in the list of <u>High-risk area</u> (Countries that are not on the list of safe countries/regions or on the lists of very high risk areas) such as **Thailand** to the Netherlands are required:

- To present **negative COVID-19 test result** (**Either** a **negative COVID-19 NAAT (PCR) test result** based on a sample collected no more than **48 hours** before departure **Or** a **negative antigen test result** based on a sample collected no more than **24 hours** before departure)
- To present a **health declaration form**
- To present a <u>proof of vaccination</u> (otherwise the EU entry ban applies unless the purpose of the trip falls under one of the exemption categories)

**Customers transferring in Amsterdam-Schiphol Airport** do not need to present negative COVID-19 NAAT (PCR) test result but if required by final destination. A <u>health declaration form</u> is still required.

#### Easy Travel with KLM Upload@Home Document Check

Customers can now use KLM's 'Upload@Home' to save time at the airport and enjoy a smoother journey. This free option lets them **pre-validate required COVID-19 entry documents** through KLM website. **Eligible customers will receive an invitation to upload documents before travel**, such as negative PCR test results. KLM will check the documents and confirm via e-mail when everything is in order. Uploading must be done at **least five hours before departure**.
