



EXPRESSION OF INTEREST FOR PROVISION OF WASTE MANAGEMENT SERVICES

Eni Rovuma Basin B.V., Mozambique Branch invites interested companies to submit their *Expression of Interest* for the provision of **WASTE MANAGEMENT SERVICES** in Mozambique.

SCOPE OF WORK

The scope of this document is to provide technical specifications for Hazardous and General Waste Management and Disposal Services to be executed by the CONTRACTOR in Mozambique in compliance with APPLICABLE LAWS, in accordance with applicable international standards and the COMPANY's requirements, in support of COMPANY's operations.

The scope of work consists of provision of Waste Management Services, as detailed below:

- Provide of labour; supervision, licenses, warehousing, consumables, disposable materials, quality control associated with Waste Management Services and be responsible for safety, security, and environmental protection;
- provide waste (hazardous and non-hazardous) collection, transportation, stabilisation, analysis, treatment, and disposal services;
- collect waste from designated sites in appropriate vehicles and transport them to approved and licenced treatment and disposal facilities; The area of activity is Pemba. Collection of waste will be done at Pemba Port and at Company facilities in Pemba.
- temporarily store COMPANY's wastes (including wastewater) at a CONTRACTOR's base, when needed;
- maximise volume reduction, reuse and recycling of COMPANY's waste in authorized recycling or reutilization facilities;
- perform laboratory analysis, when needed, for all the types of solid and liquid waste;
- provide equipment for waste collection (i.e. containers, recycling bins, oil spill kits and materials, tanks, ISO tanks, boxes, etc.) suitable for the service (if and when required)
- perform environmental monitoring of Contractor's emissions and discharges.

The CONTRACTOR shall be qualified by the Ministry of Land and Environmental (MTA), for the above typology of SERVICES and shall perform them in full compliance with APPLICABLE LAW.

DOCUMENTATION REQUIRED

Companies interested in this invitation shall submit their *Expression of Interest* by providing the following mandatory information and documentation:

I. Technical documents:

- a) Documented proof of 5 years' experience in conducting waste management services preferably for the Oil and Gas Industry in Africa and / or documented proof of 5 years' experience in conducting industrial waste management services in Mozambique including Contract description and duration, Location, Client and Workforce;
- b) General information about the Company's Profile;
- c) Copy of Company's valid licenses and certificates to operate in the waste management sector; issued by the relevant Country's Authority and by competent technical bodies, relating to management, transportation, storage, treatment and disposal of hazardous and industrial waste, inside and, if needed, outside Mozambique;
- d) in case your Company does not have a valid license, please provide the evidence of the submission of the application for the license and specify the respective timeline;
- e) Reference letters from other Clients for the provision of similar services (if available);
- f) Proof of experience in waste volume reduction, reuse and recycling projects, description of performed activities;
- g) Office and waste management facilities located in Mozambique are an advantage;
- h) HSEQ Policy and copy of the Quality MS, Environmental MS and OH&S MS certifications: ISO 9001, ISO 14001 and ISO 45001 or OHSAS 18001, or evidence of applied management systems (i.e. HSE Manual, list of HSEQ MS procedures);
- i) Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided;
- j) Any other information that will establish ability of fulfilling this scope of work.

II. Administrative documents:

- a) Scanned certified copy of the Trade Register; Legal Entity name and contact person for receiving qualification package and other relevant information from

Eni Rovuma Basin B.V.;

- b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will enter into the subject contract;
- c) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique and specify the respective timeline;
- d) Company and Group Structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);
- e) In case you wish to participate in the *Expression of Interest* as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group.
