





Approval from Local Authorities (OSC), Federal/State Agencies & Technical Agencies

Description

Land use approval from Pejabat Tanah Daerah, JPPH, Pejabat Tanah & Galian,

- Land amalgamation involving the combination of two or more under separate land titles, to be held under a single land title.
- Change in category of land use.
 Land swap involving Government and private owner.

Building Plan (BP) Approval from Local Authority

Building Plan approval through OSC require approval from related Technical Agencies. Any variation from normal norm may take longer time to be approved.

Certificate of Completion & Compliance (CCC)

- Incomplete infrastructure: water reticulation, road and drainage system, landscaping.
- Delay in handover process from Industrial Park Developer to Technical Agencies (JBPM, Air Selangor, IWK).

Description

High Connection Charges

Charges depends on the distance to the nearest supply station and special features set by Local Authorities such as Horizontal Directional Drilling (HDD) and permit charges

Internet Coverage

Poor internet coverage due to insufficient demand and infrastructure

Maintenance of Industrial Estates

· Pothole, streetlights not functioning, illegal dumping sites due to lack of maintenance

Insufficient supply of water & electricity from nearest source

Water supply issues Electricity supply issues.

Insufficient gas infrastructure

• Unavailability of gas distribution pipeline in certain industrial areas.
