



DTT EXEMPTION APPLICATION

PROCESS OVERVIEW

Fairly easy process...

1.CONTRACT



Contract should be translated to Portuguese and notarized.

2. M3 FORMS



Obtained at the Moz tax authorities and completed. Send to supplier for signature by their tax authorities

13. T.R.F



Supplier to submit Tax Residance Certificate (issued by the foreign tax authorities)

SUBMIT TO TAX



Submit signed contract, M3 forms and TRF to Moz tax authority


ENGAGE THE MOZ TAX AUTHORITY EARLY

FIRST POINT

Only a handful DTTs currently

There are currently 9 DTTs in place. There is no DTT with France where our parent company is resident.

SECOND POINT

Suppliers unwilling to extend payment terms


The process takes long and there is no specific turn around times with foreign tax authorities and also with the local tax authorities. Payment may extend beyond 120 days...

THIRD POINT

Extra cost if unsuccessful

There is no guarantee for success. Should the application fail, the supplier is likely not going to accept reduced payment.
