



**EXPRESSION OF INTEREST
FOR PROVISION OF WIRELINE SERVICE**

Eni Rovuma Basin B.V., Mozambique Branch, on behalf of Eni Mozambique S.p.A, invites interested companies to submit their *Expression of Interest* for the **PROVISION OF WIRELINE SERVICE** to support operations in Area A5-A in Mozambique.



SCOPE OF WORK

The scope of work consists of Provision of Wireline Service as detailed below in order to perform the drilling activities for the deep-water exploration campaign of 1 well:

- Wireline tools for formation evaluation (radioactive licenses are mandatory)
- Pipe recovery Equipment (explosive licenses are mandatory)
- LWF and TLC Equipment
- Wireline Unit and High Strength cable
- Dedicated logistic base in Pemba surroundings, embarkation point for the equipment will be Pemba Port.

The expected spud-in date is in Q1 2022, and Contractor shall be ready to operate by November 2021.

DOCUMENTATION REQUIRED

Companies interested in this invitation shall submit their *Expression of Interest* by providing the following mandatory information and documentation:

- I. **Technical documents:**
 - a) Any relevant references for the previously executed projects of similar technical characteristics and magnitude;
 - b) Health & Safety Management System (OHSAS 18000 or ISO 45001) and Environmental Management System (ISO 14001) documents proving the company compliance with international standards;
 - c) Quality Management System certifications and/or certificates proving compliance with international Quality Standards (ISO 9001:2008);
 - d) Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided;
 - e) Any other information that will establish ability of fulfilling this scope of work.
 - f) All licenses to operate in Mozambique, in particular: import, storage and use radioactive source and explosive.
- II. **Administrative documents:**
 - a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from the Company;
 - b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will enter into the subject contract;
 - c) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mo-

zambique;

- d) Company and Group Structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);
- e) In case you wish to participate in the Expression of Interest as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group.
