



**EXPRESSION OF INTEREST
FOR PROVISION OF WASTE MANAGEMENT SERVICES**

Eni Rovuma Basin B.V., Mozambique Branch, on behalf of Eni Mozambico S.p.A, invites interested companies to submit their *Expression of Interest* for the provision of **WASTE MANAGEMENT SERVICES** to support operations in Area A5-A in Mozambique.

SCOPE OF WORK

Area A5-A is a block located offshore the districts of Larde and Angoche in the province of Nampula, in northern Mozambique.

The scope of work consists of provision of Waste Management Services, as detailed below:

- Provision of labor, supervision, licenses, warehousing, consumables, disposable materials, quality control associated with Waste Management Services and be responsible for safety, security and environmental protection;
- Provision of waste collection (hazardous and non-hazardous) from designated sites, stabilization, analysis, treatment, temporary storage and final disposal services in accordance with Local Regulations and Area A5-A Operator's HSE requirements;
- Transportation of waste in appropriate vehicles and containers up to approved treatment and disposal facilities in accordance with Local Regulation and Area A5-A Operator's HSE requirements;
- Temporary storage and treatment of Area A5-A Operator's wastes (including drilling mud/ cuttings/ slops) at a Contractor's base, when required, in compliance with Local Regulation and Area A5-A Operator's HSE requirements;
- Perform laboratory analysis, when required, for all the types of solid and liquid waste including muds, drill cuttings and wastewater;
- Ensure that the treatment and final disposal facilities are appropriate and authorized;
- Maximize recycling of Area A5-A Operator's waste over other disposal methods;
- Drilling waste to be considered under this category are:
 - spent Synthetic-Based Muds (SBMs)
 - spent Oil-Based Muds (OBMs)
 - spent Water-Based Muds (WBMs)
 - oily drilling cuttings
- Supply of equipment for waste collection and storage (i.e. certified containers, recycling bins, oil spill kit, tanks, ISO tanks, boxes, cutting skips etc.) suitable for the service (required).

- i) Any other information that will establish ability of fulfilling this scope of work.

II. Administrative documents:

- a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from the Eni Rovuma Basin B.V.;
- b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will enter into the subject contract;
- c) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique and specify the respective timeline;
- d) Company and Group Structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);
- e) In case you wish to participate in the *Expression of Interest* as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group.

Interested Companies shall be qualified and Licensed by the Ministry of Land and Environment (MTA), for the above typology of Services.

The expected spud-in date of the well is in Q1 2022, and Contractor shall be ready to operate by November 2021.

DOCUMENTATION REQUIRED

Companies interested in this invitation shall submit their *Expression of Interest* by providing the following mandatory information and documentation:

I. Technical documents:

- a) Documented proof of experience in provision of waste management services for Oil & Gas Industry in the last 5 years;
- b) Documented professional references released by customers;
- c) Documented evidences of authorizations, permits, licenses, certificates relating to waste management, transportation, storage, treatment, disposal inside and outside Mozambique;
- d) Documented proof of experience in execution of waste management services in Africa;
- e) Office and waste management facilities located in Mozambique;
- f) Health & Safety Management System (OHSAS 18001 or ISO 45001) and Environmental Management System (ISO 14001) documentation proving the company alignment with HSE international standards;
- g) Quality Management System documentation proving alignment with international Quality Standards (ISO 9001);
- h) Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided;

IMPORTANT:

The submission must refer to the Public Announcement and to the following commodity code:

5503AC02 – COLLECTION/TRANSPORT/TREATMENT/ DISPOSAL OF DRILLING/PRODUCTION WASTE RESIDUES
