1. This Request for Bids follows the General Procurement Notice for this Project that appeared in Development Business of 4th December 2015.
2. The **Government of Mozambique** has received financing from the World Bank toward the cost of **Water Services and Institutional Support Project II (WASIS II)** and intends to apply part of the proceeds toward payments under the contract for **Construction of new Distribution Center, Beira**.
3. Fundo de Investimento e Património do Abastecimento de Água (FIPAG) as implementing agency, now invites sealed Bids from eligible Bidders for **Construction of Estoril Distribution Center, Beira**. The construction period is **12 months**. The major works under this Contract comprise but are not limited to:
 - Interventions in the existing Munhava DC will include the construction of a new pumping station, a new power supply building, a new chemical building and a new connection box to the existing water tower. Furthermore, also planned are interventions in the existing water tower, a new drainage basin, the refurbishment of the existing nine circular ground reservoirs, the demolition of the existing workshop building, a new electrical installation for all planned electromechanical equipment and the replacement of all non-operating ultrasonic flowmeters;
 - New water transmission main, DN500 PN10, L=5.637,4 m (Munhava DC to Estoril DC);
 - New water distribution center in Estoril neighbourhood, comprising two ground reservoirs (3.000m³ to be build under this contract and 2.000 m³ for phase 2), 500m³ elevated tank, pumping station and all auxiliary buildings;
 - Connection from Estoril DC to water supply network.
4. Qualifications requirements include: the minimum average annual construction turnover within the last 5 years shall be **USD 15,000,000.00**. Experience under construction contracts in the role of prime contractor, JV member, Subcontractor, or management contractor for at least the **last 7 years**, prior to the applications sub-mission deadline. Participation as a prime contractor, joint venture member, management contractor or sub-contractor, in at least **3 similar contracts within the last 7 years**, each with a value of at least **USD 8,000,000.00** or **2 similar contracts of minimum value of USD 14,000,000.00**. Construction of water storage ground reservoirs with **2.000m³ minimum storage volume**; Construction of elevated reservoirs with minimum **water level height of 30m above ground-level**; Construction of water transmission mains with **minimum length of 5,0km** and minimum diameter **DN400**. Contracts experience should include supply, delivery, installation and commissioning of mechanical and electrical equipment.
5. Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's Procurement Regulations for IPF Borrowers- Procurement in Investment Projects Financing of November 2020 and is open to all eligible Bidders as defined in the Procurement Regulations.
6. Interested eligible Bidders may obtain further information and inspect the Bidding document **during office hours, from 8:30h to 15:00h** at the address given below.
7. The Bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee of **USD300.00** (three hundred US dollars) or the equivalent in Meticaís. The method of payment will be direct deposit into one of the two FIPAG bank accounts: Millennium BIM, MZM account no. 8992580, NIB 000 100 000 000 899 258 057, Millennium BIM Swift Code BIMOMZMXXXX or Banco ABC USD accounts no. 100108022028, NIB 001 300 010 010 802 202 829, Banco ABC Swift Code FMBZMZX. When requested, FIPAG will send the bidding document and the Bidder should pay for any express courier charges.
8. Bids must be delivered to the address below on or before **14:30h** local time on **December 19th 2022**. Electronic Bidding will not be permitted, Late Bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below on **December 19th 2022 at 14:30h**.
9. Each bid must be accompanied by a bid security of **USD 150,000.00** (one hundred and fifty thousand united states dollars) or an equivalent amount in a freely convertible currency.
10. Pre-bid meeting and site visit will take place on **November 17th 2022, at 9:30h AM** at FIPAG Office, Munhava Distribution Center, Munhava Neighborhood, Beira.
