- The Government of Mozambique (GoM), through the Ministry of Economy and Finance (MEF) has received financing from the World Bank towards the cost of the Mozambique Economic Linkages for Diversification Project (EL4D/PLED) and intends to apply part of the proceeds for consulting services. - 2. The Consulting Services ("the Services") include delivery of digital solutions, financial services, technical knowledge for workers, and sector-specific skills training through the implementation of the following activities:
 - Developing the content of the training delivered to 9,000 informal and formal MSMEs in 5 cities in the center and north of Mozambique.
 - Identification and selection of suitable local trainers (candidates).
 - Organization and delivery of the Training of Trainers.
 - Training implementation for consumption linkages firms.

3. The Ministry of Economy and Finance (MEF) now invites eligible Consultants to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services (brochures, description of similar assignments, experience in similar conditions and implementation of projects in accordance with environmental and social safeguard's framework, etc.).

The shortlisting criteria are:

- Demonstrated considerable experience in the delivery of digital skills' trainings to MSMEs: expected at least 1,500 MSMEs/youth/entrepreneurs trained on digital skills.
- Demonstrated considerable experience in the delivery of financial services' trainings or other services: expected at least 1,500 MSMEs/youth/entrepreneurs trained or other type of support in financial services.
- Demonstrated considerable experience in the delivery of gender-oriented programs: expected at least 1,500 women entrepreneurs receiving relevant gender-oriented interventions.
- Demonstrated considerable experience in the delivery of technical skills: expected at least 1,500 beneficiaries of technical trainings.
- Strong capacity and experience in planning, logistic and project management, including implementation of large-scale programs with large number of participants (expected of 3,000 participants and above).
- · Previous experience working in Mozambique preferred.
- · Previous experience working in Cabo Delgado Province preferred.

Key Experts will not be evaluated at the shortlisting stage.
