



EXPRESSION OF INTEREST FOR MAINTENANCE, INSPECTION AND ENGINEERING SERVICES

Total E&P Mozambique Area 1, Lda. ("TEPMA1") holds the offshore rights to explore and develop the natural gas reserves from Area 1 of the Rovuma Basin, designated Mozambique LNG project ("MZLNG").

The MZLNG projects is a greenfield development consisting in a subsea system tied back to an onshore LNG facility located 10km southeast of Palma, on Afungi Peninsula, Cabo Delgado Province.

To support the MZLNG Maintenance, Inspection and Engineering Teams (MIEC), TEPMA1 intends to contract Maintenance, Inspection and Engineering Services including inspection equipment and others applicable to the nature of the contract.

In this project, MZLNG intends to develop the facets of Maintenance and Engineering data, maintenance and engineering systems, and the identification of all components and spares to allow safe operations of both onshore and subsea facilities. The goal of this is to proactively gather engineering and maintenance information, analyze, procure spares (optional) and present for migrating into the COMPANY business systems.

In this context, TEPMA1 invites qualified entities to submit an Expression of Interest (EI) for the provision of Maintenance, Inspection and Engineering (MIE) Services, the scope of which will span several geographic locations; Milan, Italy for Onshore scope; Houston, Texas, USA for subsea scope and Afungi, Mozambique for inspection and preservation scope, will be divided into eight (8) work packages that as follows:

- Management, HSE & Services Data Recovery & Compilation
- Inspection Engineering Works
- Spare Parts and Specific Tools
- Subsea Engineering
- Safety and Environmental Critical Elements
- Maintenance, Inspection and Operating Manuals
- Hand Over of MIE Deliverables to Company

2. Submit the Expression of Interest with the following documentation:

- Company profile including audited financial information;
- Portfolio of similar projects rendered and references of clients in the Oil & Gas Industry;
- Detailed information about the competences and relevant experience of the company or entity;
- Operational License or equivalent document issued by the relevant authorities;
- Health, Safety and Environmental (HSE) policy or dedicated procedures
- Registration of initiatives or participation in Sustainable projects in Mozambique
- Local Content plan implemented in other projects
- Company footprint in Mozambique, indicating facilities and nr of employees/sub-contractors

3. The Submission of the Express of Interest must be structured and grouped in separate folders according to the topics above described for easy identification and analysis.

If the Expression of Interest is submitted by a consortium, it shall be accompanied by the consortium agreement, which shall define the respective terms and conditions, the duration and the form of participation of its members.

The participation of national companies or entities is encouraged.

Following receipt of Expressions of Interest, TEPMA1 may select companies for further pre-qualification. The submission of an Expression of Interest does not guarantee that a company will receive an invitation to tender.
