



ANNOUNCEMENT OF EXPRESSION OF INTEREST

Van Oord Gulf FZE, in a partnership with Technip Middle East FZCO, have been awarded a contract for the Mozambique LNG / Gofinho EPCI project in northern Mozambique by Total E&P Mozambique Area 1.

This contract covers the Engineering, Procurement, Construction and Installation (EPCI) of the subsea systems. Van Oord Gulf FZE will execute the shallow water offshore installation scope.

Van Oord Gulf FZE invites interested parties to submit an Expression of Interest for the provision of HEAVY CONSTRUCTION EQUIPMENT.

The works to be performed comprise of the supply of heavy construction equipment, including operators, for the nearshore dredging and pipe pull operations.

For this Van Oord Gulf FZE requires interested parties to deploy:

- ✓ CAT 390 excavator equipped with a window guard and with the possibility to include a raiser, to be supplied with a closed bucket and a skeleton bucket;
- ✓ CAT 349 excavator with wide (90cm) tracks with a window guard, to be supplied with a closed bucket and a skeleton bucket;
- ✓ CAT D6 LGP bulldozer equipped with an escape hatch and a recovery bridle;
- ✓ CAT 980 wheel loader with a quick fit system (fork, closed bucket, skeleton bucket);
- ✓ Crawler crane (400 tonnes).

The works to be executed shall meet the following quality standards:

- ✓ All proposed equipment to meet, as a minimum, oil and gas industry standards (or equivalent);
- ✓ All equipment subject to Project standards and audits;
- ✓ 24/7 maintenance / service coverage.

- ✓ Relevant track record.

After this deadline Van Oord Gulf FZE will review the feedback received and if it meets the above requirements add the interested party to its list of possible subcontractors / suppliers for the applicable scope of work.

Thereafter, as soon as the sourcing process for a certain scope of work commences, a pre-qualification will follow for selected registered companies.

The participation of national companies or entities is encouraged.
