Van Oord Gulf FZE, in a partnership with Technip Middle East FZCO, have been awarded a contract for the Mozambique LNG / Golfinho EPCI project in northern Mozambique by Total E&P Mozambique Area 1.

This contract covers the Engineering, Procurement, Construction and Installation (EPCI) of the subsea systems. Van Oord Gulf FZE will execute the shallow water offshore installation scope.

Van Oord Gulf FZE invites interested parties to submit an Expression of Interest for the provision of AIRCRAFT CHARTER SERVICES.

For the execution of its scope of work, Van Oord Gulf FZE are seeking local companies that can provide in-country airline services. The service to be supplied comprise of in-country Airline services for our personnel on the route Maputo to Afungi on a weekly basis.

The airline service is part of the overall logistical process of performing our crew changes to/from our project field. Due to the timing of this process, the routing needs to include an overnight of the aircraft preferable in Pemba, Mozambique.

For this Van Oord Gulf FZE requires interested parties to deploy:

- ✓ Weekly roundtrip services on the route MPM-AFG-POL - overnight - POL-AFG-MPM, fully dedicated to Van Oord.
- ✓ Including all terminal handling, hospitality arrangements at each airport, ability to carry small pieces of cargo.

The works to be executed shall meet the following quality standards:

- ✓ Limitation on the private domestic airfield in Afungi are the length of 1600m and width of 45m;
- ✓ ISO9000 or equivalent;
- ✓ Environmental Policy Statement and/or Corporate
