**Songo - Matambo 400kV Overhead Transmission Line Project**  
(Extension and Upgrade of Songo and Matambo substations)

1. The Government of Mozambique (GoM) has received financing from the African Development Bank (the "Bank") toward the cost of **Songo - Matambo 400kV Overhead Transmission Line Project**, and intends to apply part of the agreed amount for this Grant to eligible payments under the contract with an Owner's Engineer for the **Design, Preparation of Tender Documents, Assistance During the Pre-Contract Stage, Construction Supervision and Technical Assistance during the Defects Liability Period for the Extension/upgrade of 2 (two) EHV substations** namely the Songo substation and the Matambo substation. The services included under this assignment are:
  - Prepare Detailed Project Design for extension/upgrade of Substations;
  - Prepare Bidding Document and provide support in the whole tendering process up to contract signing and defects liability period;
  - Supervise the construction works of the contract which will result from these activities;
  - Provide technical support in contract management of a contract which will result from these activities; and
  - Capacity Building of EDM staff part of the PIU (On job/ Learning By Doing Process).
2. The duration of the assignment is 12 months for phase I, 36 months for phase II and 12 months for phase III.
3. The Electricidade de Moçambique E.P, now invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may constitute joint- ventures to enhance their chances of qualification.
4. Eligibility criteria, establishment of the short-list and the selection procedures shall be in accordance with the "Procurement Policy for Bank Group Funded Operations, dated 2015, which is available on the Bank's website at <http://www.afdb.org>.
5. A consultant will be selected in accordance with the QCBS selection method set out in the Bank Operations Procurement Manual - Part A, Volume 1- dated November 2018.
