1. This Request for Bids follows the General Procurement Notice for this Project that appeared in Development Business of 4th December 2015.
2. The Government of Mozambique has received financing from the World Bank toward the cost of **Water Services and Institutional Support Project II (WASIS II)** and intends to apply part of the proceeds toward payments under the contract for **rehabilitation and construction of distribution centres and network, Pemba.**
3. The Fundo de Investimento e Património do Abastecimento de Água (FIPAG) now invites sealed Bids from eligible Bidders for **rehabilitation and construction of distribution centres and network, Pemba.** The construction period is **15 months.** The major works under this Contract comprise but are not limited to the following:
 - a. Expansion of about 150 km of network and reinforcement of the existing network, including establishment of district metering areas;
 - b. Replacement of about 22 km of network including transfer of connections from the old to new network and decommission of the old network;
 - c. Rehabilitation of the existing distribution centres;
 - d. Construction of new distributions centers.
4. Bidding will be conducted through open competitive procurement using Request for Bids (RFB) as specified in the World Bank's Procurement Regulations for IPF Borrowers- Procurement in Investment Projects Financing of July 2016, revised November 2017 and August 2018 and is open to all eligible Bidders as defined in the Procurement Regulations.

The Bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **USD300.00 (Three Hundred US Dollars)** or the equivalent in Meticais.
