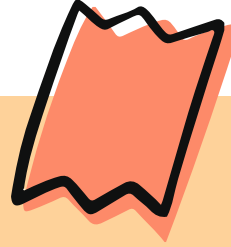

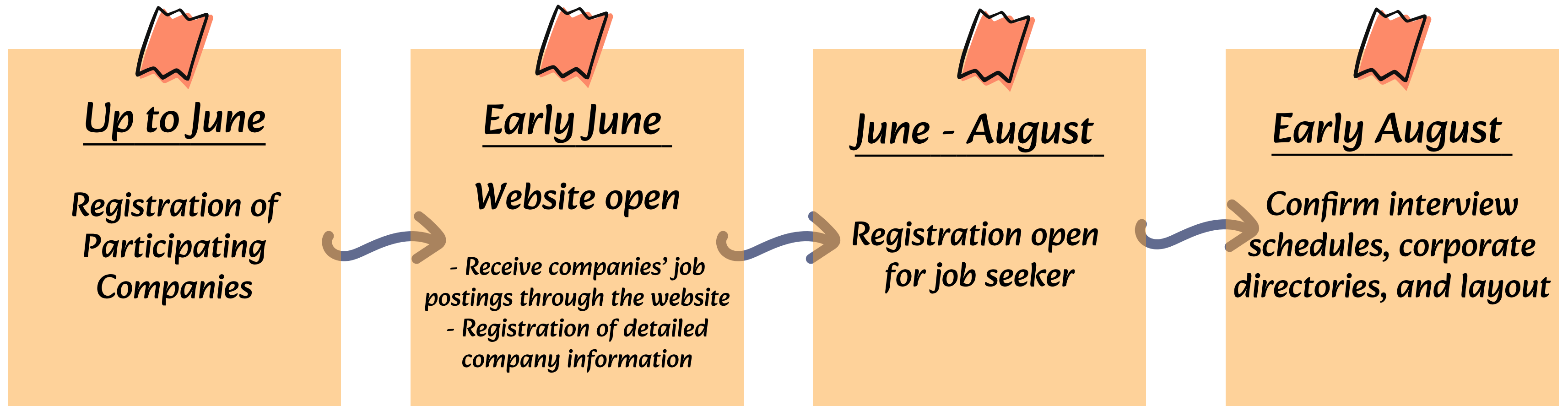
Separate rental equipment is an individual burden (monitor, display shelf device, etc.) and will be announced separately at an appropriate unit price after confirming with the booth device company

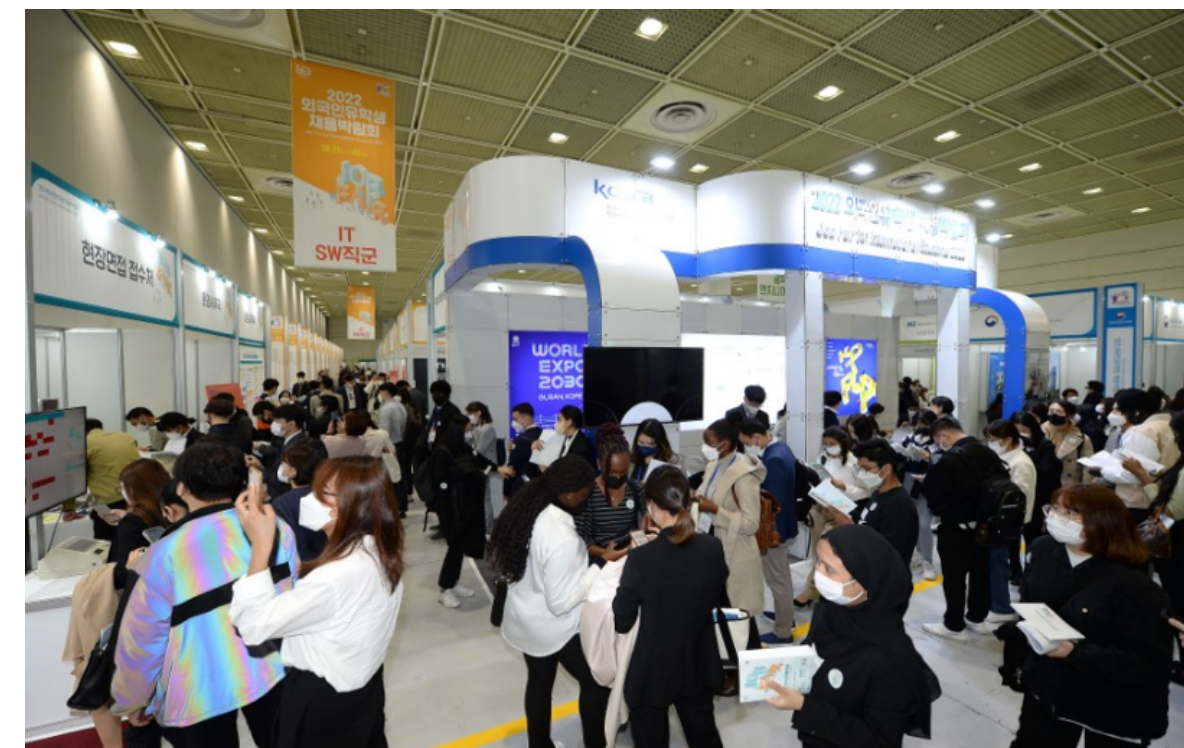

We will provide you with the best opportunities to meet various job seekers!

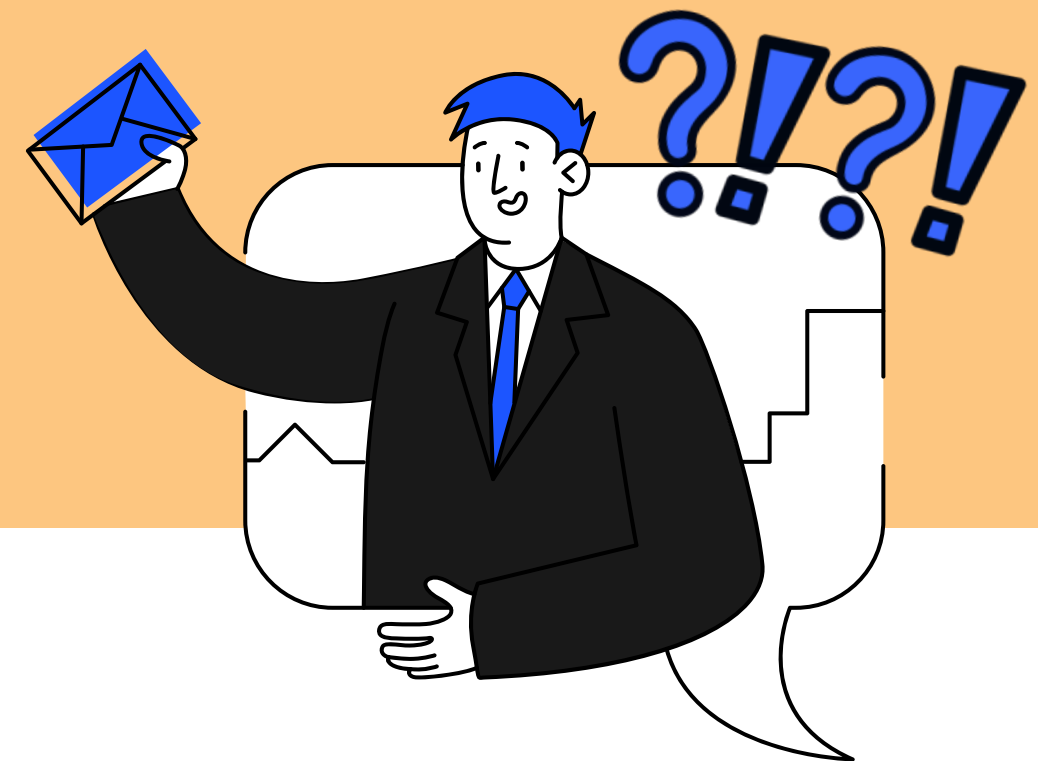
Q. Do I need a confirmed hiring plan to participate?
