**Recruitment of a printing company to reproduce training and communication material on value chain development aspects**

- This Invitation for Bids follows the General Procurement Notice (GPN) for this project (Ref. Nr. UN-P541168-07/20) that appeared in UNDB online on 24 July 2020.
- Since May 2020, the Government of Mozambique is implementing the Inclusive Agri-food Value-Chain Development Programme (PROCAVA), co-financed by the International Fund for Agricultural Development (IFAD) through the Loan No. 2000003236 and Grants Nrs 2000003237 and 2000003626, with the aim of supporting the development of five (5) value chains (Horticulture, Cassava, Red Meat, Legumes and Poultry), in seventy-five (75) districts of all 10 provinces of Mozambique, targeting 180,500 households, mainly smallholder farmers, during ten (10) years.
- PROCAVA is implemented by the Ministry of Agriculture and Rural Development (MADER), being the Fund for Agricultural Promotion and Rural Extension (FAR, FP), the entity responsible for Programme coordination, which in turn, ensures daily Programme management and implementation through a National Programme Management Unit (NPMU) based at its headquarters in Maputo city, Regional Programme Management Units (RPMU) based at FAR, FP provincial Delegations (FAR, FP - Del) of Gaza, Manica and Nampula provinces, and a Provincial Programme Management Unit (PPMU) in Niassa province.
- As to ensure functional Programme Management Units, FAR, FP intends to apply part of the PROCAVA funding to recruit a printing company to reproduce training and communication material on value chain development aspects.
- As such, interested companies with, the required documents stated below, are invited to submit proposals in a sealed envelope at the address indicated in paragraph 8.
- The qualification documents are as follows: (a) Technical Qualification Documents: Certificate issued by UFGA; Legal Registration certificate; Company statutes published in the National Gazette; Commercial Permits; Proof of experience with similar supplies, presenting at least 3 similar supply contracts; (b) Legal Qualification Documents: Commercial registration certificate; Declaration that the bidder has no impediments imposed by the national legislation for bidding purposes; National Institute of Social Security Certificate; Valid fiscal certificate; National Institute of Statistics Certificate; (c) Economic and Financial Qualification Documents: (i) Company's income statements issued by legal third party entity to reflect average annual turnover over the past three years shall be at least equivalent to 1,5 times the value of the bid or (ii) Confirmation by official letter by legal entity confirming access to credit to the value of the bid; A statement that the company has not declared bankruptcy issued by relevant court;
- Bidders can bid for one or more lots, and according to the lots bided, bidders must submit the following physical samples:** For lot 1: Physical sample of one (01) brochure, which will be provided electronically upon purchase of the bidding document; For lot 2: Physical sample of one (01) sticker for car door, logo will be provided electronically upon purchase of the bidding document; For lot 3: Physical sample of the PROCAVA logo embroidered on a piece of cloth. The logo will be provided electronically upon purchase of the bidding document.
- The bidders may obtain more information and /or details, by examining the tender documents or purchasing them by the non-refundable amount of one thousand five hundred meticais (1,500.00 MT), upon presentation of a confirmation of deposit, at the address indicated in paragraph 8, from Monday to Friday, at working time that is 07:30 am to 3:30 pm.
