- Proposition annexes if any: Please, provide a financial offer in MZN including at least: unit cost, VAT, etc...
- Having a representation in Pemba is a plus
- Terms & conditions of payment
- Validity of offers

### Documents to be supplied:

- A detailed offer. Prices must be net, excluding VAT and including VAT.
- Proven experience in processing work permits and work visas. Proof of similar experience with other clients (NGOs, United Nations agencies, etc.)
- To be duly registered and legalized to operate in Mozambique
- Recommendations or letters of approval from non-governmental organizations (preferred)
- Up-to-date discharge and INSS certificate
- Commercial license and certificate
- Updated list of beneficial owners
- No financing of terrorism
- A sample contract
