1. The Government of Mozambique has received financing from the World Bank toward the cost of the IFRDP, and intends to apply part of the proceeds for Consultancy Services for a Senior Transport Specialist for ANE.
2. The overall objective of the assignment is to assist the head of the PIU in the fulfillment of tasks under the IFRDP and other World Bank funded projects.
3. The detailed Terms of Reference (ToR) for the assignment can be obtained at the address below.
4. The National Road Administration, *Administração Nacional de Estradas*, now invites eligible Individual Consultants to express their interest in providing the Services for two years with six months of probation period. The contract may be extended subject to availability of funds and performance. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.
5. The evaluation of expressions of interest will be made on qualitative basis according to a robust matrix of strengths and weaknesses and the shortlist will be composed from the list of qualified individual consultants considering the following criteria:
 - At least a master's degree in one of the following disciplines: Highway/Civil Engineering, Transport/Infrastructure Planning, Transport Economics, or Urban Transport disciplines;
 - At least 10 years' experience in transport operations, management of transport infrastructure projects, including experience in contract administration, planning and programming of capital and maintenance works and/or institutional reforms;
 - Comprehension of typical sectoral issues in transport, including sector policy reforms, and management and financing of transport infrastructure;
 - Professional registration is a requirement;
 - Experience in the design, supervision or implementation of roads construction, rehabilitation and maintenance, including bridges and drainage structures;
 - Knowledge/previous experience in projects financed by bilateral/multilateral development agencies is desirable;
 - Experience in managing financial, procurement, environmental, social, monitoring and evaluation aspects of transport infrastructure projects is required;
 - Knowledge of World Bank's Environmental and Social Safeguard Policies is desirable;
 - Very good knowledge of National procurement Standards/regulations, The International Federation of Consulting Engineers (FIDIC) and Financiers Standards for civil engineering contract forms, Southern African Transport and Communication Commission (SATCC) specifications and experience with a range of Donors' and institutional requirements;
 - Good level of computer literacy, especially Microsoft Excel, Microsoft Word, and Project;
 - Fluency in English language is essential and knowledge of Portuguese will be an asset.
