Coral FLNG S.A ("COMPANY"), an SPE registered under the laws of the Republic of Mozambique for the development of the Coral South Project, the first LNG project in Mozambique based on first worldwide Deepwater Floating Liquefied Natural Gas plant, invites interested companies, to submit an Expression of Interest for the provision of point to point (PtP) wireless link from offshore Coral Sul FLNG to onshore sites for Coral FLNG SA in Mozambique.

SCOPE OF WORK

The scope of work includes the following phases:

- Project Phase: CONTRACTOR will Engineer, procure, construct, commission, and startup the link. The link should have, minimum, synchronous bandwidth capacity of 100Mps. This phase includes, but not limited to, the provision of:
 - Technology to be used;
 - Infrastructure (towers, masts, antennas, base stations, etc);
 - Installation services and Training.
- Operation Phase: CONTRACTOR will provide maintenance, support and internet services.
 - Maintenance will be according to agreed maintenance plan;
 - Provision of spares parts;
 - Provision of onsite and remote support with strong Key Performance Indicators (KPI);
 - Provision of internet services (same as link capacity);
 - SLA above 99.5 for link availability;
 - Link enhancement, if necessary.

- A copy of Company's last three years of audited financial statements/Annual Report proving financial capacity for the realization of the scope of work; these documents must be provided for the Company Group (if applicable) and also for the Company's entity that will potentially enter into the subject contract;
