EXPRESSION OF INTEREST FOR DRILLING OPERATIONS OFFSHORE BY DRILLSHIP REVISION .01

Eni Mozambico S.p.A – Mozambique Branch, Operator of Area 5-Allense in Mozambique, invites interested companies to submit their *Expression of Interest* for the provision of **DRILLING OPERATIONS OFFSHORE BY DRILLSHIP** to support Eni Mozambico S.p.A Mozambican Branch exploration activity in Mozambique.

Such Drillsip is required to have the following characteristics:

- Full dual activity drilling rig
- Dynamic Positioning Unit required to be fit for H2S Service;
- Dynamic Positioning Unit required to be fit & equipped for Zero Discharge;
- Rated Water Depth – min 2400 m;
- Drilling Depth – min 5400 m;
- Derrick Capacity 2,000,000 lbs.
- Equipped with at least 1 ROV unit & personnel to provide 24h service per day;
- Drillsip 5th generation upward;
- Minimum five years of proven drilling activities;
- Proven experience operating in cyclone areas;
- Five-year certification due not earlier than Q4-2023.
- Equipped with cementing unit and fully commissioned

The contract foresees

- A **firm period** needed to perform drilling and abandonment activities on one (1) well in Mozambique, plus additional three (3) wells in direct continuation in West Africa for an Eni Affiliate. The expected spud-in date of the well is in **Q4-2022/Q1-2023**;
- Plus, an **optional period** needed to perform drilling, well testing, abandonment and completion of additional six (6) wells in direct continuation.

Rig contractor MUST open a local branch in country with administrative & operative management based in Maputo and dedicated logistic base in Pemba within one month before spud-in date.

DOCUMENTATION REQUIRED

Companies interested in this invitation may submit their *Expression of Interest* to participate in a tender process for offshore drilling operations through drillsip by registering on the website indicated below and submitting the following required documentation demonstrating an evidence of:

- Technical documents:**
 - a) Information about the proposed rig, including name and availability window, confirming the approximate time when the rig can arrive in Mozambique;
 - b) Information on ability to meet the above listed technical requirements;
 - c) Technical specification, data sheets and owner of ROV, cementing and mudlogging units;
 - d) Technical data sheet, P&I and drawing of Zero Discharge Solid Control Systems (i.e. number of G-dry, number of augers, etc.);
 - e) Having an extensive experience of executing drilling operations offshore involving a Drillsip compliant with the above listed characteristics;
 - f) Any other information that will establish ability of fulfilling this scope of work.
- Administrative Documents:**
 - a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from Eni Rovuma Basin B.V.;
 - b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will enter into the subject contract;
 - c) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique and specify the respective timeline;
 - d) Company and Group Structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);

- e) In case you wish to participate in the *Expression of Interest* as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group.
