By request bid documents will be sent by express mail, for which additional advance amount specified in the Bid Data Sheet shall be paid. In case of differences between pdf file and printed copy, this one will prevail.

All bids must be accompanied by a bid security of **USD 800 000, 00 (Eight Hundred Thousand United States Dollars)**. Late bids will be rejected. Bids will be opened at **10:05 hours on January 27, 2023** at the address referred above, in the presence of the bidder's representatives who choose to attend.
