The Provision of Mechanical, Piping, Electrical, Instrumentation and Civil Construction Services



SASOL

Sasol Petroleum Temane Limitada ("Sasol") (hereafter referred to as Sasol) operates facilities in Mozambique, including the Temane Central Processing Facility (CPF) and various production wells and gas flow lines in the Pande area. In order to maintain the supply of raw gas to the CPF and meet its long-term gas sales agreements, Sasol is planning to install additional wells in the Pande field.

The Project seeks the services of a Mechanical, Piping, Electrical, Instrumentation and Civil Contractor. The Contractor will be required to:

- Fabricate and paint process piping spools;
- Field install coated steel underground gas flow lines, including Cathodic Protection;
- Conduct x-ray inspection and other non-destructive testing of welds;
- Apply field joint coating at welds;
- Hydro-test, cleaning plus drying and certify the constructed flow lines;
- Conduct internal dimensional inspection (pigging) of the installed pipelines;
- Construct civil platforms, groundworks and concrete and steel structures;
- Supply and install electrical works;
- Supply and install control and instrumentation works;
- Integrate supplied instrumentation into an existing control system.

The Contractor will need to mobilise qualified personnel, at a remote location, for the duration of the works. Sasol will provide the design and engineering of the Works. The Contractor shall be responsible for the management of own sub-contractors and service providers, if required.

This request is intended to solicit information required to enable Sasol to identify and assess suitably qualified and experienced Contractors registered or established and operating in the Republic of Mozambique, in order to create an opportunity for such Contractors to potentially participate in the future bidding for this project.

Sasol hereby invites eligible Contractors to indicate their interest to bid for specific construction works identified above. Interested Contractors should provide appropriate information showing that they have the required qualification(s), ability, expertise, skills, capacity and relevant experience to perform the Work.

Kindly refrain from submitting any irrelevant information and documentation. Kindly ensure that each item hereunder is addressed and that your submission is structured strictly in accordance with the list of required documentation and information hereunder:

1. Sasol has been over the years a driver of socio-economic development through its investments and operations. A key aspect of this development impact has been enabled through its commitment to Local Content. Sasol is fully committed to improved levels of local content and supports the local content requirements for the procurement of goods and services which are designed to promote the development of Mozambican owned businesses and know-how. The aim is to maximise procurement from Mozambique owned (majority and minority) and Inhambane Head Quartered companies. Accordingly, Sasol encourages interested Contractors to maximize any potential local participation when responding to this Request for EOI. Relative to Local Content, Contractors are to:

- a. Provide detail of the Contractor's ownership structure [percentage shareholding held by shareholders as well as a description of the identity of shareholders] and details of registration of the company in terms of Mozambican legislation.
- b. Contractor to indicate if the company is a Mozambican registered entity, a Mozambican minority owned entity or a Mozambican majority owned entity. Contractor to also indicate whether the company has Head Quarters in Inhambane.
- c. Provide Contractor's company commercial license and registration documentation in terms of Mozambican Legislation.

2. Technical capability

- a. Provide a detailed track record of work performed over the past 5 years specifically for the referenced category.
- b. Provide details of work performed for Sasol in Mozambique over the last 5 years.
- c. Provide full details of the following: Contractor's technical skills; equipment quality and capacity; resources' skills, qualifications, experience and capacity; planning systems / progress measuring system; and workshop capacity to proof that it can successfully execute the Work applicable to the referenced category.

3. Provide details of part/s of the Works that will be Sub-contracted and provide information of the proposed sub-contractors.

4. Provide Information and detail of the Contractor's

accredited quality, health, safety and environmental management systems as well as all applicable accreditations.

5. Provide detail of the Contractor's knowledge and experience with the NEC (New Engineering Contract).

6. Cover letter with contact details (e-mail address, name and phone number) of Person responsible for tenders.

Potential bidders will be selected in terms of Sasol's evaluation criteria [as determined by Sasol], considering the details that the Contractor supplies, all other information [including all risks associated with this project]. Potential bidders will be selected by Sasol in its sole and unfettered discretion.

Contractors who satisfy the pre-qualification criteria will be required to sign a confidentiality agreement with Sasol, prior to receiving any further information regarding the project and for the purpose of further commercial process.

Responses by Sasol will only be made to short-listed prospective bidders and Sasol may request further information from such identified bidders. Sasol may also arrange for auditing of information that has been provided by a respondent pursuant to this EOI.
