The Government of Mozambique has received financing from the World Bank toward the cost of the Mozambique Urban Sanitation Project and intends to apply part of the proceeds toward payments under the contract for Construction of 4400 Household Toilets in Tete (3 lots). For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing.

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers- Procurement in Investment Projects Financing" of July 2016, revised November 2017, August 2018 and November 2020 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from DNAAS and inspect the Bidding document during office hours 07:30 to 15:30 at the address given below.
5. The document will be provided to prospective Bidders through a link to download the files. DNAAS is not accountable for changes or damage to download the files.
6. Bids must be delivered to the address below on or before 10:00 h, May 24<sup>th</sup>, 2023. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below at 10:00 h, May 24<sup>th</sup>, 2023.
