## EXPRESSION OF INTEREST FOR PROVISION OF DIRECTIONAL DRILLING MWD/LWD SERVICE

**Eni Rovuma Basin B.V., Mozambique Branch**, Offshore Operator delegate of Area 4 Mozambique Rovuma Basin, invites interested companies to submit their *Expression of Interest* for the provision of **DIRECTIONAL DRILLING MWD/LWD SERVICE** to support **Eni Rovuma Basin B.V.** gas field development activity in Mozambique.

### SCOPE OF WORK

The scope of work consists of provision of Directional Drilling MWD/LWD Service as detailed below in order to perform the drilling activities:

- Provide a measurement-while-drilling, logging-while-drilling and directional drilling services, **including but not limited to:**
  - Automated Steerable Systems
  - Measurement While Drilling tools (MWD)
  - Logging While Drilling tools (LWD)
  - Bottom Hole Assembly (BHA) components (eg. Stabilizers, Cross-overs, Non-magnetic DC, JAR, circulation sub, underreamer, etc)
  - Surveying service
  - Monitor of drilling parameter in real time, telemetry
- Dedicated logistic base in Pemba surroundings equipped of all facilities for preparing and testing drilling tools, embarkation point for the equipment will be Pemba Port;
- Administrative & Operative Management based in Mozambique;

### Directional Drilling MWD/LWD Service, including but not limited to:

- Dedicated logistic base in Pemba surroundings equipped of all facilities for preparing and testing drilling tools, embarkation point for the equipment will be Pemba Port;

### The development project foresees:

- A firm period needed to perform the drilling, completion and cleanup of four (4) wells in Mozambique Area 4. The expected spud-in date of the well is in Q3-2025 with possible starting of the completion and well testing operation in Q4-2025.
- Plus, an optional period needed to perform the drilling, completion and cleanup of two (2) wells in Mozambique Area 4.

- j) Registration of the company in Mozambique. If not duly registered, the participant shall indicate whether it would be willing to register promptly and the estimated period for doing so;
- k) Financial Statements for the past three years and Annual Report including Balance Sheet, Profit and Loss and Cash Flow statement. These documents must be provided by the Company's Group (if applicable), and also by the Company registered in Mozambique that will conclude the contract;
- l) Structure of the Company or Group with the list of main shareholders and final beneficiaries (if not listed on any stock exchange);
- m) If the Expression of Interest is to be submitted as a Consortium or Joint Venture (JV), information regarding each member belonging to the Consortium or JV with the respective role/position that each member will take in the potential project. The intention to form a Consortium or JV must be supported by an Agreement or "Memorandum of Understanding" duly signed by each member of the group.

The foreseen contract duration will be of one firm period of three (3) years plus two (2) options of one (1) year each.
