

**EXPRESSION OF INTEREST  
FOR PROVISION OF PROJECT MANAGEMENT SERVICES**

**Eni Rovuma Basin B.V., Mozambique Branch** invites interested companies to submit their *Expression of Interest* for the provision of **PROJECT MANAGEMENT SERVICES** to support operations in Mozambique.

**SCOPE OF WORK**

Scope of the work is to provide Project Management Services (PMS) within Mozambique (mainly in Maputo, Nampula and Cabo Delgado), including but not limited to support the following activities: Project Management, Engineering, Data Management, Permits & Consents, Quality Control and Assurance, HSE and Sustainability Services, Operation Readiness, System Testing, Commissioning and Start Up, required for the Offshore Projects in Mozambique. Services will be required indicatively starting from Q2-2022 for a period of three (03) years.

**DOCUMENTS REQUIRED**

Companies interested to participate in this *Expression of Interest*, may submit the following mandatory information and documentation providing evidence of:

**I. Technical documents:**

1. Being an Engineering and Project Services Company with proven experience in EPC Project Management, including Engineering (FEED, Detailed Engineering), Project Services, Quality Control and Quality Assurance Services, HSE and Sustainability Services, Electronic Data Management, Construction Management, Site Characterization Supervision, Human Factors Engineering, Compliance with Statutory Regulations and Local Content Requirements, Commissioning and Start Up Services, development of Permits & Consents required for Offshore Projects;
2. Documented professional references released by international customers for performing similar services in the last 5 years;
3. Health & Safety Management System (OHSAS 18000 or ISO 45001) and Environmental Management System (ISO 14001) documents proving the company compliance with international standards;
4. Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided;
5. Quality Management System certifications and/or certificates providing the company compliance with national or international Quality Standards (ISO 9001);
6. Documented proof of experience in Mozambican Permits & Consents, and consolidated knowledge of the Mozambican regulatory framework;
7. Any other information that will establish that your company is capable of fulfilling the scope of work.

**II. Administrative documents:**

- a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from Eni Rovuma Basin B.V.;
- b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will enter into the subject contract;
- c) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique and specify the respective timeline;
- d) Company and Group Structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);
- e) In case you wish to participate in the *Expression of Interest* as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV,

must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group.
