SCOPE OF WORK

The Operator in its committed to support social development in the area of operation (Pemba - Cabo Delgado) aims to implement specific projects in the area of Education to contribute for quality education in Cabo Delgado Province through the construction and rehabilitation of school infrastructures and sport facilities.

Within this context, the Operator requires a suitable and qualified CONTRACTOR to perform the WORKS which shall consist of providing Engineering, Procurement and Construction services for the following main activities:

- Rehabilitation and Construction of Schools Infrastructures for Students, i.e. provision of services for design, rehabilitation/construction of school infrastructures, including multipurpose fields, based on a list of applicable international standards provided by the Operator and the standards of the Ministry of Education and Human Development of Mozambique (MINEDH);
- Supply and Installation off-grid small scale Solar Photovoltaic Systems;
- Provision and supply of Didactic Material, School Furniture and Sports Equipment, based on international standards and the standards of the Ministry of Education and Human Development of Mozambique (MINEDH) and the Ministry of Youth and Sports.

- d) Any other information that will establish that the company is a capable of fulfilling the scope of work.

II. Administrative documents

- a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from the Eni Rovuma Basin B.V.;
- b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will enter into the subject contract;
- c) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique and specify the respective timeline;
