PUBLIC ANNOUNCEMENT EXPRESSIONS OF INTEREST FOR Maintenance Services for Floating LNG Facility

Coral FLNG S.A ("COMPANY"), an SPE registered under the laws of the Republic of Mozambique for the development of the **Coral South Project**, the first LNG project in Mozambique based on an under construction first worldwide Deepwater Floating Liquefied Natural Gas plant, invites interested companies, to submit an Expression of Interest for the provision of maintenance services for its Floating LNG facility, in Mozambique (offshore and onshore).

SCOPE OF WORK

The scope of the work includes the following CONTRACTOR'S responsibilities:

- Put in place maintenance organization onshore and offshore capable of executing COMPANY'S Maintenance Plan
- Provide Maintenance services in the following disciplines:
 - Static Equipment
 - Piping
 - Valves
 - Relief Valves
 - Rotating Equipment
 - Instrumentation and Control Systems
 - Electrical
 - Coating and Painting repair
 - Insulation
 - Scaffolding
 - Welding and machining
 - HVAC
 - Lifting Equipment and Cranes
 - Safety Equipment
- Coordinate and execute the preventive maintenance plan that shall be submitted by COMPANY
- Coordinate and execute all corrective maintenance activities
- Coordinate and execute turnaround activities
- Coordinate and execute seasonal maintenance campaigns
- Develop and operate an onshore workshop to support the FLNG maintenance activities
- In order to deliver the maintenance services satisfactorily, provide qualified resources competent to maintain floating LNG facility as per COMPANY'S Competency Management System
- Provide all regular tools, consumables, lubricants and industrial gases required for his activities.
- Develop and execute a Local Content Development Plan to be implemented during the execution of the SERVICES
 - Beside the base scope described above, other optional services shall be included as follows:
 - Purchase of spare parts
 - Technical support by OEM
 - Underwater inspection
 - Underwater maintenance
 - Brown field modifications
 - Maintenance and inspection engineering services
 - Production Services

DOCUMENTATION REQUIRED

Companies interested in this invitation may submit their Expression of Interest (EoI) to participate in a tender process for "Technical, Operation and HSE Training Services for the Oil & Gas and LNG Business" by providing the following mandatory information and documentation:

Technical documents

- A copy of Company's valid license to operate issued by the relevant authority.
- Brochure.
- Quality Management System certification or demonstration of having a QMS in place aligned with international standards (ISO 9001).
- Health, Safety & Environment Management System certification or demonstration of having a HSE MS in place aligned with international standards (ISO 14001 and ISO 45001).
- Evidence of minimum cumulative 5 years of experience in managing and executing either global maintenance, general maintenance, repair maintenance, turnaround maintenance or maintenance & modifications contracts at onshore LNG liquefaction facility and;
- Evidence of minimum cumulative 5 years of experience in managing and executing either global maintenance, general maintenance, repair maintenance, turnaround maintenance or maintenance & modifications contracts at floating production facilities (FPSO or FLNG) or offshore platforms.

N.B. For points 5&6, the evidence document shall be submitted as a standalone document including the following data:

- Client
- Location
- Scope of Work in details
- Value
- Start date & end date
- Total man hours
- Last 3 years KPI's for HSE performance, if applicable
- Last 3 years KPI's for Maintenance service performance, if applicable.

Any evidence document not in compliance with the above requirements shall be disregarded.

- Evidence of any offices/branches/training centers in Mozambique and/or abroad.

Administrative documents

- A copy of the commercial legal entity registration certificate, with legal entity name and contact person for receiving qualification and commercial information;
- In compliance with Mozambican Commercial Code (Decree 2/2005 dated December 27, 2005) Company shall prove in its EoI to be registered or incorporated and duly authorized to operate in Country. In the event that at the date of EoI submission Company has not obtained yet the required proof of registration/incorporation, it shall demonstrate that the process of registration/incorporation in Mozambique has been already started at the EoI submission date and it shall submit a written declaration stating the date it expects to prove COMPANY of its registration/incorporation in Mozambique.



- A copy of Company's last three years of audited financial statements Annual Report proving financial capacity for the realization of the scope of work; these documents must be provided for the Company Group (if applicable) and also for the Company's entity that will potentially enter into the subject contract.
- Company and group structure with the list of major shareholders and ultimate beneficiaries (if not listed in the stock exchange).
- In case Company wish to participate as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group.

Coral FLNG SA will evaluate the above requested documentation and, if satisfied, will include the Vendor in the list for invitation to tender for "Provision of maintenance services to Floating LNG facility".

The purpose of the information and documents is to identify qualified companies that have the proven capability and recent relevant experience to be considered for potential invitation to tender for "Provision of maintenance services to Floating LNG facility".

This enquiry shall not be considered as an invitation to bid and does not represent or constitute any promise, offer, obligation or commitment of any kind on the part of Coral FLNG SA to enter into any agreement or arrangement with you or with any other Company participating in this enquiry.

All data and information provided within the application shall not be considered as a commitment on the part of CORAL FLNG SA to enter into any agreement or arrangement with you, nor shall it entitle your COMPANY to claim any indemnity from CORAL FLNG SA. Data and information clearly marked as "confidential" provided pursuant to this enquiry will be treated as confidential by CORAL FLNG SA, and will not be disclosed to non-authorized persons or companies.
