The Government of Mozambique has received a loan from the International Development Association toward the cost of Power Efficiency and Reliability Improvement Project (PERIP), and it intends to apply part of the proceeds of this loan to payments under the agreement resulting from this IFB: III14/PERIP/2021.

2. The Electricidade de Moçambique, E.P. serves as the implementing agency for the project and now invites sealed bids from eligible Bidders for Supply, Installation and Commissioning of network solution (hardware and software) to provide an end-to-end digital network infrastructure as a replacement of the current old legacy infrastructure at EDM including training.

3. Bidding will be conducted using the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, edition of May 2004, revised October 2006 and May 2010, and is open to all Bidders eligible as defined in these Guidelines,<sup>5</sup> that meet the following minimum qualification criteria: financial statements acceptable to the Employer, for the last five (5) years, minimum average annual turnover for contracts in progress or completed, in the last five (5) years: USD 15,000,000.00, minimum of five years' experience in supplying or manufacturing and installation of Active Equipment, experience in at least two contracts for supplying and installing similar goods and type test reports and certificates from the relevant International or National Testing/Standards Authority.

4. Interested eligible Bidders may obtain further information from Electricidade de Moçambique, E.P. and inspect the bidding documents at the address given below from 08:00 to 14:00 hours -

6. Bids must be delivered to the address below at or before 26th October 2021. Bids need to be secured by a Bid-Securing Declaration. Late bids will be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend at the address below at 26th October 2021, 10:00 local time.

The attention of prospective Bidders is drawn to (i) the fact that they will be required to certify in their bids that all software is either covered by a valid license or was produced by the Bidder and (ii) that violations are considered fraud, which can result in ineligibility to be awarded World Bank-financed contracts.
