EXPRESSION OF INTEREST FOR PROVISION OF UPPER COMPLETION EQUIPMENT & ENGINEERING SERVICES

Eni Rovuma Basin B.V., Offshore Operator delegate of Area 4 Mozambique Rovuma Basin, invites interested companies to submit their *Expression of Interest* for the **Provision of Upper Completion Equipment & Engineering Services** to support **Eni Rovuma Basin B.V.** gas field development activity in Mozambique.

SCOPE OF WORK

The scope of work consists of provision of **Upper Completion Equipment & Engineering Services** as detailed below to perform the Upper completion operation:

- Providing, Upper completion down hole equipment 13Cr material, including 7" Safety Valve, 7" chemical injection mandrel, down hole gauge, 10 3/4" production packer etc.;
- Installing and testing upper completion equipment;
- Providing services as engineering, quality control and quality check, testing, workshop and offshore supervision and equipment assembly preparation and storage;
- Providing full buy back option for equipment leftover;
- Trained and experience personnel to service the contract;
- Administrative & Operative Management based in Mozambique;

Provide Upper Completion Equipment & Engineering Services, including but not limited to:

- Dedicated operative base in Pemba surroundings, including torque machines to prepare completion assembly.

The development project foresees:

- the drilling, completion and clean-up of four (4) wells in Mozambique Area 4. The expected spud-in date of the well is in Q3-2025 with possible starting of the completion and well testing operation in Q4-2025.

- c) Registration of the company in Mozambique. If not duly registered, the participant shall indicate whether it would be willing to register promptly and the estimated period for doing so;
- d) Financial Statements for the past three years and Annual Report including Balance Sheet, Profit and Loss and Cash Flow statement. These documents must be provided by the Company's Group (if applicable), and also by the Company registered in Mozambique that will conclude the contract;
- e) Structure of the Company or Group with the list of main shareholders and final beneficiaries (if not listed on any stock exchange);

If the Expression of Interest is to be submitted as a Consortium or Joint Venture (JV), information regarding each member belonging to the Consortium or JV with the respective role/position that each member will take in the potential project. The intention to form a Consortium or JV must be supported by an Agreement or "Memorandum of Understanding" duly signed by each member of the group.

CONTRACT DURATION

The foreseen contract duration will be of one firm period of three (3) years plus two (2) options of one (1) year each.

- Quality Management System certifications and/or certificates proving compliance with international Quality Standards (ISO 9001:2008);
- Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided;
- List of HSE Documents (Procedures, operating Instructions) applicable for the scope of work.
