EXXONMobil Moçambique Limitada, (EMML) for and on behalf of Mozambique Rovuma Venture S.p.A ("MRV) invites interested Ground Transportation providers that are duly qualified to submit their expression of interest ("Expression of Interest") to provide Ground Transportation Services to support ExxonMobil activities, and expatriate residents, in the Republic of Mozambique. Operations will be based in Maputo and Cabo Delgado.

SCOPE OF WORK

The scope of work includes the provision of recent model SUVs, Minivans and Buses (preferable makes from Ford, Mitsubishi, Nissan, Toyota) and personnel in the roles of Supervisors and Trainers, Dispatch Coordinators and Drivers. The contract also requires supporting Ground Transport management systems, training delivery and technology that includes in vehicle monitoring systems (IVMS).

The services provider must be available to commence with the full range of contracted services effective and in place by 1 June 2023. Statement on local content and use of local suppliers

The purpose of the information and documents is to identify qualified service providers with proven capability, and relevant experience. EMML will evaluate the requested documentation and, if satisfied, will include the interested companies in the list for invitation to tender for the services.

- CVs of key management and technical personnel.
- Overview of contractor's Safety, Security, Health and Environmental plan.
