1. Present proof of the legal existence of the Bidder (Prime Contractor and partners) namely: Articles of Association, Certificate of Commercial Registry and License;
2. Possess proved experience in works of a similar nature and volume (at least 03 references of execution of works of similar dimensions and proven by means of the presentation of reference letters or duly signed contracts);
3. Present the Finance and Social Security Clearance Certificate;
4. Present the declaration that no insolvency and recovery proceedings are in progress against the company, issued by the competent entity;
5. Present the company profile highlighting the relevant and adequate experience to the object of the MI and the client portfolio (certification/accreditation to perform audits to ISO 17025:2017; qualified technical team, certified by Training Entity and, with proven experience of at least 5 similar works performed with ISO 17025:2017; demonstrate to have performed at least 10 (ten) works of Audit to the Quality Management System of Laboratory, based on ISO 17025:20; demonstrate to have provided training and audit services in companies of the hydroelectric sector, is an advantage)
6. Present the accounts report for the last 5 years (Balance Sheet and audited financial statements) proving that the bidder has the necessary financial strength to perform the services intended to be contracted.
