Hidroeléctrica de Cahora Bassa, SA («HCB») intends to hire a specialized consultancy company to carry out a consultancy and supervision services for slope stabilization works on the North Bank of the Zambezi River adjacent to the Cahora Bassa Dam and on the side of the road from Songo village to the dam site.

The HCB hereby invites Applicants to show their interest in delivering the Services described above.

This Request for Expressions of Interest is open to Consulting firms. Interested Applicants must provide information evidencing that they are qualified and experienced to perform those Services and fulfill the following minimum eligibility requirements.

To this aim, companies interested in participating must meet and prove the following eligibility requirements:

1. The Applicant shall have a certificate of commercial registration that authorizes them to carry out the activity;
2. Proven track record experience of at least ten (10) years in the consulting and supervision services of slope stabilization projects involving rock anchors, netting, gabions and concrete revetments;
3. The Applicants shall provide an overall average annual turnover of at least US\$ 1 million per year, for the past 5 years;
4. The Applicants shall provide an average annual turnover on specific activities similar to the current scope of works, performed in last five (5) years;
5. Provide reference letters of a minimum of 3 (three) similar successful projects in the last five (05) years, whose dimension and complexity are equal to or greater than the above-mentioned works with fees in excess of US\$ 500 thousand per assignment;
6. Present the company profile, highlighting its experience, area of expertise, human resource's structure, including its qualifications and competences;
7. Submit the Declaration that no insolvency and recovery proceedings have been filed against the company;

8. Tax and Labour Certificate of good standing;
