Exclusive CXO Roundtable with Axis Bank

Ms. Shweta Pahuja, Regional Director (Western Region), IFCCI opened this session and shared her welcome remarks. To begin with **Mr. Saugata Bhattacharya**, Chief Economist, Axis Bank shared a focussed overview on **'Path to a USD 7 trillion economy by 2030'** and introduced the topic with his theme presentation. In his opinion, Manufacturing is going to play a key role in thriving this goal.

Under the set context of **'Managing Forex Risk in a volatile environment'**, **Mr. Brejesh Chalill**, Head of Treasury and Markets, Axis Bank highlighted the Rocky Recovery in a global context and the USD Index measures the value of the US \$ against the basket of Global currencies while foreseeing better days ahead with INR.
