



EXPRESSION OF INTEREST FOR PROVISION OF BUNKERING SERVICES OF MARINE GASOIL

Eni Rovuma Basin B.V. Mozambique Branch, Area 4 upstream delegated Operator on behalf of Mozambique Rovuma Venture S.p.A, invites interested companies to submit their Expression of Interest for the provision of **BUNKERING SERVICES OF MARINE GASOIL** to support offshore operations in Area 4, Mozambique.

SCOPE OF WORK

The scope of work consists in the provision of BUNKERING SERVICES OF MARINE GASOIL to support offshore operations in Area 4, offshore Mozambique as detailed below:

- Contractor shall be requested to provide BUNKERING SERVICES OF MARINE GASOIL in Offshore Mozambique to continuously support COMPANY operational activities for Area 4, offshore Mozambique.
- MGO Estimate Monthly Requirement: 2500 m3/month approximately;
- Sulfur content shall not exceed 0.05% (500 ppm) as per COMPANY requirement and in accordance with the applicable Mozambican and International Regulations, whichever is more stringent.

The fuel supplied shall comply with Mozambican applicable legislation and Marpol 73/78 Annex VI, Reg. 13, 14 and 18, as amended from time to time and meeting the following International Standard ISO 8217:2017 Category F-DMA as per the following specifications:

I. Technical documents:

- Distribution License issued by the Mozambican authority as per Decreto no. 89/2019 (Licença de Distribuição);
- Proven experience in the provision of Bunkering Services of Marine Gasoil for Oil and Gas industry;
- Reference letters of previous services attesting bidder's experience in Oil & Gas industry for ship-to-ship and port supply of Marine Gasoil. ALTERNATIVELY written self-declaration signed by top management attesting the list of companies and the period when CONTRACTOR provided MGO services to oil & gas sector;
- Having Quality Management System certifications proving compliance with international Quality Standards (e.g. ISO 9001:2008 / 2015).

HSE Documents

- Health, Safety and Environment Management System documents and certificates proving compliance with international standards (ISO 45001 and ISO 14001);
- Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents

- Rate (TRIR) shall be provided.
- Environment License to perform the Activity under the Scope of Work.
- Approved Environmental and Social Management Plan.

- In case you wish to participate in the Expression of Interest as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group.
