The Government of Mozambique has received financing from the World Bank toward the cost of the Rural and Small Towns Water Security Project and intends to apply part of the proceeds for consulting services. The objective of this consultancy assignment is the supervision of construction, rehabilitation and expansion of intake, water treatment plant, transmission mains, distribution centers, pumping stations, electrical power supply line four (4) small towns - Nametil, Malema, Namialo and Namapa, in Nampula Province.

The consultancy services ("the Services") will include the day-to-day supervision and contract management; quality, time and costs control processes and procedures for the works. It will also include supervision of the construction and equipment installations, commissioning and hand-over of the Schemes, including defects liability period, in accordance with the Conditions of Contract, specifications, drawings and compliance with ESMP and RAP.

Currently, a consultancy service is ongoing to prepare the detailed design for the four (4) above referred towns, and it is expected that the tender for the work contract in two lots to be issued by October 2022, with contract awarding expected for April 2023.

AIAS, the implementing agency, now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. **The shortlisting criteria are:**

- A reputable Civil Engineering Consultancy firm with at least 15 years' experience in water Engineering, including design and supervision of water treatment plant, DC and distribution network based Urban or Small Towns Water Supply Systems. Specific experience in design check is necessary.
- **The firm should have proven supervision of:** (i) at least three projects in surface abstraction systems with minimum capacity of 350 m³/h, (ii) at least three projects of water treatment plants including rapid/ slow sand filters and iron removal with minimum capacity of 7500 m³/day, (iii) at least two projects of transmission mains (rocky areas experience is an advantage) with GS pipe of 300mm, distribution center with storage capacity of 4500m³, network and pumping stations.
- The Consultant should be fully conversant with World Bank procurement documents of Contract and construction of projects in developing countries. Experience working in Mozambique will be considered an advantage
- The consultant should also be conversant with World Bank Environmental and Social Framework and Safeguards Policies and applicable World Bank Group Environmental, Health and Safety Guidelines.

Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" November 2020 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Quality and Cost Based Selection method set out in the Procurement Regulations.
