The Government of Mozambique (GoM), *has received* financing from the African Development Bank and the Strategic Climate Fund toward the cost of the the Baixo Limpopo Irrigation and Climate Resilience Project (BLICRP) and intends to apply part of the agreed amount for this *Grant* for payment under the contract for *Assessment of economic, financial and business model for Regadio do Baixo Limpopo, Gaza province.*

The project is seeking for a qualified firm to carry out an Assessment of Financial and Business Model of RBL for transition into a self-reliance and Market-Oriented agency, conduct an economic and financial analysis (including businesses, assets, projects, budgets, solvency, liquidity, profitability and other finance-related entities) to determine RBL performance and potential needs for capital and monetary investments, in addition to assessing operational reforms.

The overall goal is to ensure that proposed reforms at all levels of the organization are conducive to RBL financial and organizational sustainability in medium to long-term. The exercise should be informed and coordinated with the ongoing reform processes to ensure that it is aligned with government plans.

The duration of the services is 90 days.

The Regadio do Baixo Limpopo EP now invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may constitute joint-ventures to enhance their chances of qualification.
