





#### EXPRESSION OF INTEREST ISION OF HELICOPTER SERVICES IN SUPPORT OF OFFSHORE FOR THE PI OPERATIONS, MOZAMBIQUE

Eni Rovuma Basin B.V. - Mozambique Branch invites interested companies to submit expressions of interest for the Provision of Helicopter Services in support of Offshore Operations, in Mozambique

#### SCOPE OF WORK

The helicopter services to be provided cover the standard offshore passengers transportation, internal cargo flights, Medical Execuation from the offshore installations to operations base, flight to move personnel that is critical to solve technical emergencies on the offshore installation.

In light of the double task, and for covering any grounding of one helicopter, the Company requires three (3) helicopters, with the following minimum characteristics and scope:

- Two pilots plus 12 passengers capacity;
- FAR/EASA CS 29;
- Maximum take-off mass (MTOM) <21 tons and D<27;
- Available payload, to reach the offshore installation at 140NM from airport and come back without refueling.
- not less than 950 k:
- Passengers transportation;
- Limited internal cargo transportation;
- Dangerous Goods transportation is not expected, although the operator is required the capability for:
   Limited SAR, meaning the capability of limited search and of launching Emergency Liferafts;
- Approved Medical Evacuation configuration, two (02) stretchers.

The service will be provided by means of three (3) sole use primary helicopters: one (1) of them is meant as the Emergency Response Asset and as back-up unit, to replace the primary one being unserviceable or under maintenance Number of helicopters in service could increase by one unit, even two, according to the operations needs

The expected area of operations, is about 150 nm North of Pemba Airport

The operations base is the airport of Pemba (FQPB - POL): operation base could change but, in this case, agreement with the operator will be sought and all expenses due to the movement will be reimbursed

Adequate manning, in terms of Pilots, Technicians and administrative personnel shall be granted, in order to ensure, further than normal flights (expecting 5 days per week, 4 flights per day), H24 7/7 Emergency Response.

- f) HSE Management System Manual or list of documents/procedures evidencing alignment with international standards (e.g. ISO 14001; OHSAS 18001 or ISO 45001) and/or evidence of a certified HSE Management System;

- a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from Eni Rovuma Basin B.V.;
- b) Last three years of Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the
- Company's Mozambican registered entity that will enter into the subject contract;
