REQUEST FOR EXPRESSION OF INTEREST
CONSULTANCY SERVICES FOR PERFORMANCE MONITORING
AND QUARTERLY REPORTING

Hidroeléctrica de Cahora Bassa, SA («HCB») intends to hire a consultant to perform monitoring and quarterly reporting of HCB's performance. As part of the process, HCB requests for expressions of interest (EOI) from interested and specialised companies with the aim of pre-selecting competing companies.

The summarized scope of the work to be carried out consists of carrying out independent monitoring of HCB's activities, reflected in quarterly reports, that reflect the company's operational performance, covering the following areas:

- Finances;
- Operations (including but not limited to the technical-operational performance status of the Generation System, the HVDC Converter Station, the Power Transmission Lines, the Reservoir Infrastructure Management, Health and Safety at Work and Environmental Management, with highlight to Significant Events);
- Status of Major Projects.

Companies interested in participating must meet and prove the following eligibility requirements:

1. Hold a licence that entitles them to carry out the activity;
2. Minimum of 10 years of company or key staff allocated to the project (evidenced by company portfolio or CV of key staff) experience and qualifications in consultancy and advisory services in Power and Energy industry, hydropower utility particularly in the similar scope of the present project. The consultant must provide 3 reference letters or signed contracts of similar scope;
3. Minimum of 10 years of company or key staff allocated to the project (evidenced by company portfolio or CV of key staff) experience and qualifications in Consultancy and advisory services in reservoir management, dam safety, generation, HVDC conversion, HVDC and HVAC transmission as well as health, safety and environment (HSE). The consultant must provide 3 reference letters or signed contracts of similar scope;
4. Present the finances and labour compliance certificates;
5. Prove that is not in conflict of interest

All interested companies that meet the minimum requirements above mentioned must express their interest by submitting all documentation and evidence proving their eligibility by means of electronic mail:
