SELECTION OF A COMPANY FOR THE OPERATIONALIZATION OF SVC Plus COMPENSATION EQUIPMENT, LOCATED IN MOCUBA

Electricidade de Moçambique, E.P. (EDM) Mozambique Power Utility, intends to hire a national or international Company for the Operationalization of an SVC Plus Compensation Equipment located in Mocuba district, Zambeze province, Mozambique. As such, EDM invites all interested and eligible companies to express their interest in providing such services, according to the following:

- 1. The tender is open to national and/or international companies, stablished in Mozambique or abroad.
- 2. The bidders must provide the necessary qualifying documents, that proves their ability and eligibility to perform the intended services according to the Initial Selection Documents Works.
- 3. Joint Ventures between the interested companies, to strengthen their qualifications, is allowed.
- 4. All interested and eligible companies are invited to express their interest by submitting a cover letter along with the company's documents. The Expression of Interest if submitted in Portuguese there is no need to translate, but if submitted in a different language other than Portuguese must be translated.
- The number of copies are as the following: 1 (one) original and 1 (one) soft copy (Flash-drive) with the same content as the hard copies (EDM will accept proposal sent by e-mail).
- 6. The structure of the Expression of Interest must obey the qualification forms in the Initial Selection Works Documents.
- 7. A maximum of 08 (eight) of the best qualified bidders will be short listed and invited to submit technical and financial proposals, in a closed envelope, in accordance with the ToR that will be provided by EDM, after all bidding companies have been duly notified on the results of the expression of interest.
- The evaluation of the expression of interest will be based on the criteria mentioned in Initial Selection Works Documents.
- The contract will be valid for 36 (thirty-six) months, of which 12 (twelve) months will be for the implementation of the
 project and 24 (twenty-four) months for the guarantee of the equipment and services.
- The closing date for Bidders to submit their Expression of Interest is the 15th of December 2023, at 09:30 am (09:30 am Mozambique standard time), in the below address:
