Maputo, 1 October 2020 SELECTION OF AN INDEPENDENT POWER PRODUCER FOR THE DEVELOPMENT OF A 30MW/40 MW, SOLAR PHOTOVOLTAIC

PROJECT

- On September 30, 2020, the Government of Mozambique launched Programa de Promoção de Leilões de Energias Renováveis (Promotion of Renewable Energy Auction Programme or PROLER), which will contribute to the increase of power generation capacities and to the diversification of energy sources, and give priority to competitive and transparent tender procedures for the selection of private investors with the required level of technical and financial capacities and interest in the development of projects of renewable energy generation, leading to the choice of least-cost solutions for customers.
- The Government of Mozambique has received funds from the Agence Française de Développement (French Development Agency)
 to support the PROLER, which is a programme of solar photovoltaic and wind projects to be developed through an Independent
 Power Producer (IPP) approach for a total capacity of around 120 MW.
- 3. In order to select an experienced and qualified private developer and/or investor to finance, design, construct and operate a 30MW/40MW_p solar PV Project in Dondo, Province of Sofala (the "Project"), the Ministry of Mineral Resources (MIREME), trough the Energy Regulatory Authority (ARENE), now invite Applicants meeting the prequalification criteria detailed in the Prequalification Documents to submit an Application.
- 4. The selection of the IPP will be made through a competitive tender with prequalification and ARENE, acting in the capacity of Procuring Authority. Preliminary information related to the PROLER programme is provided in Part II of Prequalification Documents. It is expected that Invitations for Bids will be issued during the first quarter of 2021 to prequalified Applicants. It will further define the scope of the Project and include strong requirements regarding local participation.
- Applications must be submitted in a sealed envelope before 16 November 2020 at 10:00 am (local time), at the addressed mentioned below:
