

- The French Business Council Dubai & Northern Emirates is **updating its constitution**. The former constitution of our organization **dated of 2003**.
- These changes are submitted to approval to the FBC Members. If these changes are not approved by FBC Members, the current Constitution will stay.

# Why these updates of constitution?

- To move with the times and adapt our activities to the current business reality, as the former constitution is 15 years old (2003).
- To adapt FBC's activities to the new Dubai and UAE laws.
- To adapt FBC's governance to manage our organization efficiently and have more visibility in the long-terms actions, to reinforce FBC's governance, its efficiency and long term performances.

# How these updates of constitution have been done?

- With a committee composed of lawyers, FBC board members and managing director.
- With further feedback from the FBC members.
- With the review and approval of the Dubai Chamber of Commerce and Industry.
- With a benchmark of best practices of other International French Chambers of Commerce in other countries.
- With the support and advices of "CCI France International", our HQ in Paris.





# Changes - Updates - Quorum & Voting

## **2018 Updated Constitution**

### **Quorum & Voting**

- **General meetings**: Proxies may only be granted to other Members and shall be limited to two (2) proxies per Member.
- Extraordinary meetings: The quorum shall be fiftyone percent (51%) of the Members, present or represented through a proxy.

### **2003 Current Constitution**

### **Quorum & Voting**

- **General meetings**: ... at any annual general meeting, a member cannot hold more than three (3) proxies besides his own vote.
- Extraordinary meetings: The quorum for all extraordinary general meetings shall be sixty six (66%) of the FBC members eligible to vote.



# **Updates – Executive Committee and Permanent Team**

## **2018 Updated Constitution**

#### **Executive Committee - Composition - Tenure :**

- The Executive Committee shall be composed of twelve (12) directors elected for a tenure of two (2) years.
- It shall not be possible to be a Director more than four (4) consecutive Tenures (8 years maximum).

#### Officers:

- The President of the Executive Committee shall be francophone.
- Both vice-presidents have the same duties.

#### **Permanent Executive Team:**

• The Executive Committee may appoint a permanent team of employees including an Executive Director. They cannot be member of the FBC in any category of Membership.

### **2003 Current Constitution**

#### **Executive Committee - Composition – Tenure :**

- The FBC shall be administrated ... at the annual general meeting to be held in October each year.
- The president's term can be renewed by the Executive Committee, twice at most – meaning a maximum of 3 annual terms.

#### Officers:

- The President of the Executive Committee shall be a French citizen.
- Differentiations of duties between the 1st Vice-President and the 2nd Vice-President.

#### **Permanent Executive Team:**

• The Executive Committee shall recruit a non-member Director. The Executive Committee shall establish his/her attributes as well as salary.



# New elements

## **Establishment**

- Creation of a "Code of Ethics".
- Review of FBC liability.
- Affiliations with the Dubai Chamber of Commerce and the network of the French Chambers of Commerce and Industry abroad (CCI France International).
- Closer cooperation with other institutions and organizations.

## Membership

- Three categories of Membership Ordinary (Corporate and Individual Membership), Associated and Honorary.
- Honorary Membership includes the Chairman of the Dubai Chamber, the past FBC Presidents.
- Honorary President shall be appointed by the Executive Committee. Conditions of Membership for Honorary Members apply.



# New elements

### **Council of Elders**

Creation of a "Council of Elders".

## Miscellaneous

- Introduction of the confidentiality and Personal data protection.
- Ability to use Smart Business, digitalization and blockchain.
- For some evolving topics, policies and regulations will be set internally to offer flexibility of operation.
- The Dubai Chamber might be consulted for non-objection of this updates of Constitution.
- A draft version of the constitution will be shared with members.

## **General Meeting**

- A General Meeting can be totally or partially digitalized (under conditions).
- Notice for a General Meeting can apply.
