Hidroeléctrica de Cahora Bassa, S.A. («HCB») intends to contract company(ies) for the supply of routine material for the core business, for stock replacement. In this sense, this Request for Expression of Interest (RFI) is made to all specialized and interested companies, in order to carry out the pre-selection of the competing companies

The above-mentioned material is grouped in seven (6) lots as mentioned below

To achieve this objective, companies interested in participating must satisfy and demonstrate the following eligibility requirements:

- 1. EOI letter signed by the person empowered to bind and obligate the company;
- 2. Proof of the legal existence of the Bidder (Prime Contractor and partners) namely: Articles of Association and Certificate of Commercial Registry;
- 3. Accounting and financial documentation for the last 3 fiscal years (balance sheets and income statements);
- Declaration that there is no bankruptcy petition against the company, that it has not applied for composition with creditors, and that there is no insolvency or recovery request (must be issued by a Competent Entity);
- 5. Tax clearance certificate updated no less than 90 days prior to the deadline for submission of bids;
- 6. Social Security clearance certificate updated no less than 90 days before the





deadline for submission of bids;

7. Presentation of certificates/partnership agreements with the suppliers of the brands they represent.

All interested companies that meet the minimum requirements above mentioned must express their interest by submitting all documentation and evidence proving their eligibility by means of electronic mail: concurso-material-diverso-es@hcb.co.mz, until September 8th, 2023.
