The 2026 Franco-British Business Conference will take place during a period of significant transformation. Energy systems, defence capabilities, and digital technologies are being reshaped by geopolitical rivalry, supply-chain disruptions, and the accelerating green and AI revolutions.

Businesses face the dual challenge of maintaining resilience while remaining competitive in an increasingly fractured world.

Key Programme Elements

Sovereignty has emerged as the defining frame across sectors

- **Energy** sovereignty means building low-carbon systems that are both secure and affordable.
- **Defence** sovereignty means ensuring our nations can act swiftly and independently while strengthening alliances.
- **Digital** sovereignty means reducing reliance on external providers, scaling European AI innovation, and enabling SMEs to adopt transformative technologies.

The conference theme highlights the importance of turning high-level declarations into actual results. Business require tangible delivery: quicker procurement processes, innovative financing instruments for SMEs, cross-border skills pipelines, and Franco-British industrial projects that demonstrate the partnership's worth.

Cross Cutting Themes

- **Agility:** how governments and industries can adapt at the pace of technological and geopolitical change.
- **SMEs and mid-tier firms:** ensuring the benefits of cooperation extend beyond large corporates.
- **Skills and talent:** training, mobility, and apprenticeships to underpin every sectoral transition.
- **Sovereignty as resilience:** energy, defence, and AI sovereignty understood as the foundation for competitiveness and growth.

Key Program Elements

Opening Business Scene-Setter – Challenges and Opportunities in 2026:

A leading economist will open the conference with a data-driven overview of the global and European business environment. From shifting energy markets and geopolitical risk to the AI revolution and SME competitiveness, this keynote will set the scene with key facts and figures delegates need to frame the day's discussions.



CEO Interview

Led by a prominent and senior journalist, this high-profile interview with a leading Franco-British CEO will examine how global companies are adjusting to the challenges of energy transition, digital transformation, and geopolitical fragmentation.



Panel Sessions

Defence & Economic Security *From Doctrine to Delivery*

Against a backdrop of rising geopolitical tension, this panel will examine how Franco-British defence cooperation can move from high-level agreements to practical delivery. Themes include aligning procurement and export controls, embedding shared doctrine, and ensuring industry – from primes to SMEs – can adapt at the pace of modern threats while strengthening European security.



AI, Digital & Industrial Innovation *From Hype to Adoption*

With the UK showing far higher SME adoption rates than France, and Europe as a whole grappling with questions of digital sovereignty, the discussion will focus on what policies, partnerships and investments are needed to make AI a driver of competitiveness rather than a source of fragmentation.



Energy & Climate Transition *From Security to Competitiveness*

This session will explore how the UK and France can leverage their complementary strengths (e.g. French nuclear leadership and UK offshore wind) to build secure, low-carbon energy systems that also promote competitiveness. The discussion will focus on interconnectors, grid reinforcement, meeting demand in growth sectors like AI and data centres.



Closing Fireside Chat - *Where Next for UK-France Cooperation?*



A concluding dialogue between senior UK and French officials will distil the day's discussions into clear, forward-looking priorities. Anchored in themes of sovereignty, skills, and SME competitiveness, the fireside chat is policy-oriented, designed to transfer the key business insights back into government.
