# MOZAMBIQUE AT A GLANCE

## Country Overview

Mozambique offers significant economic potential, especially in **energy** (gas, hydroelectricity, solar), **agriculture, mining, transport & logistics, and tourism**. At the same time, the country faces major challenges, including insecurity in Cabo Delgado and persistent poverty. To address these, **economic reforms** have been introduced, such as reducing VAT from 17% to 16% and launching an e-visa system to simplify travel. The government is also actively seeking foreign investment to drive growth.

Covering **800,000 km<sup>2</sup>** with a population density of 41.3 inhabitants/km<sup>2</sup>, Mozambique ranks **183rd out of 189** on the Human Development Index (UNDP). The national currency is the **Metical** (1 USD = 64 MZN; 1 EUR = 74 MZN as of January 2026). The economy relies mainly on **agriculture** (73.2% of employment), **services** (22.4%), and **industry** (4.4%). Key trading partners include **South Africa, China, and India**.

## Key Growth Sectors:

- **Natural Gas:** Major projects include Coral Sul FLNG (ENI, USD 8B), Coral Norte FLNG (ENI, USD 7.2B), Mozambique LNG (TotalEnergies, USD 23.5B), and Rovuma LNG (ExxonMobil, USD 25B).
- **Electricity:** National electrification reached 60% in 2024, with a goal of 100% by 2030. The Mphanda Nkuwa hydroelectric dam (1.5 GW, led by EDF and TotalEnergies) is under development.
- **Mining:** Mozambique has diverse resources, including coal, aluminum, rubies, graphite, and heavy sands.
- **Transport & Logistics:** The country is served by five main ports and three regional logistics corridors.
- **Agriculture:** Contributes 23% of GDP and employs 75% of the workforce.



# MOZAMBIQUE AT A GLANCE

## Key Economic Indicators

In 2025, Mozambique has a population of **36.2 million**. Its **GDP is USD 22.5 billion**, with a GDP per capita of USD 623. The country's growth rates were **6% in 2023**, **1.9% in 2024** (mainly due to socio-political unrest following the October 2024 presidential elections), with expectations of 1.8% in 2025. Economic growth is projected at 3–5% in the coming years, while **inflation stands at 3.3%**.

## Political Context

Mozambique gained independence from Portugal in **1975**, followed by a civil war that lasted until 1992. The **current president, Daniel Chapo**, a member of the **FRELIMO** party (Mozambique Liberation Front), was elected in October 2024 and took office in **January 2025**. He is the **fifth** President of the Republic of Mozambique.





## MOZAMBIQUE-FRANCE TRADE RELATIONS

In 2023, bilateral trade between France and Mozambique reached **EUR 130 million**, with a EUR 40 million trade deficit for France. Mozambique mainly exports **precious stones and ferrous metals** to France, while France exports **equipment, including electrical machinery**.

French investment in Mozambique is strong and growing. Major energy players such as **TotalEnergies** (Mozambique LNG gas project) and **EDF** (hydroelectric projects) lead the way, alongside around **50 French company subsidiaries**, including **Technip Energies, CMA-CGM, AGL, Schneider Electric, Bureau Veritas, Saint-Gobain, SotMoz / Vinci Energies** and more.

These partnerships highlight the strategic and long-term economic ties between France & Mozambique, creating opportunities for growth, knowledge transfer, and collaboration across multiple sectors.
