- ... has continuously worked towards breaking barriers towards social and economic equity, this could be within innovation, finance, culture or any other area of the workplace (or in the private life as it spills over into workplace culture and ethics).
- ... is overall an incredible person who engages and inspires people around them.

To award someone from you team or your company for this award, please send us a brief description as to why your nominee should win the award and how they embody one or all of the above descriptions. IT Committee Award 2025

The IT Committee Award this year will be centered on the use of AI in the workspace, and will be given to someone nominated within our network by their colleagues or themselves, who:

- ... has consistently explored new AI applications, showing a readiness to fail fast and cheaply on multiple attempts.
- ... has demonstrated entrepreneurial and innovative strategies in the implementation of artificial intelligence.
- ... has successfully integrated AI in secure and beneficial ways for the company, their colleagues, or their own work, leading to concrete and significant advantages and value for the business or society at large.

The IT Committee Award is an intersectional and non-gendered award and may be given to **any person**. ESG Committee Award 2025

The ESG Committee Award is centered on sustainability, though this can be environmental, social or governance related. The award will be given to someone nominated within our network by their colleagues or themselves, who:

- ... has integrated sustainable practices into all aspects of their work-life (or even private life), and who is a true inspiration to their peers and coworkers.
- ... is continuously raising awareness of the need for sustainable practices.
- ... has proved significant positive impact through their ESG commitments and efforts.
