### IS YOUR BUSINESS READY FOR ISRAEL?

## I. Background

Individuals and companies conducting business in the Middle East, and in particular the United Arab Emirates ("UAE"), often face cultural and legal challenges while doing business. One such challenge was the Federal Law Number 15 of 1972 ("UAE Boycott Law" or "Law") banning deals with State of Israel ("Israel").

In 1972, the UAE enacted the UAE Boycott Law which prohibits dealings with individuals of Israeli nationality and the trade of Israeli goods.

Following the recent announcement of the peace accord between UAE and Israel, President His Highness Sheikh Khalifa bin Zayed Al Nahyan, has issued a Federal Decree-Law No. 04 of 2020 ("Federal Decree" or "Decree"), abolishing the UAE Boycott Law on August 28, 2020.

Based on the Decree, individuals and companies in the UAE may enter into agreements with bodies or individuals residing in Israel or belonging to it by their nationality, in terms of commercial, financial operations, exchange or possess Israeli goods and products of all kinds in the UAE and trade in them or any other dealings of any nature.

#### II. Outlook

The implementation of the Decree represents a huge milestone for the UAE and international business landscape in terms of ease of doing business.

In particular it will have a significant impact on the routinely requested boycott request of a UAE company in relation to its international counter party.

Many foreign individuals or companies conducting business in the Middle East, and in particular the UAE, have been routinely requested to enter into agreements containing provisions that require the foreign contracting party to participate in the boycott of Israel.

Such requests are often in the form of apparently innocuous contractual provisions requiring the foreign contracting party to "comply with all applicable laws in the UAE", in short meaning also to comply with the UAE Boycott Law.

Agreeing to such contractual provisions has created challenges in particular for foreign companies, which were regulated by countries where anti-boycott laws (e.g. USA) are in place, which could potentially cause foreign contracting parties to fall afoul of applicable domestic laws, resulting in fines or prison sentences, if there were to agree to the boycott request of the UAE contracting party.

In such situation lawyers were engaged to negotiate amendments and changes to contractual language to ensure compliance with domestic anti-boycott laws and the UAE Boycott Law, in order to facilitate the business deal.

Moving forward and with the above-mentioned changes in mind, we strongly suggest reassessing previously executed agreements to ensure compatibility with the recent developments. MENA LEGAL will be delighted to assist you with this exercise.
