The Republic of Mozambique has received financing from the World Bank toward the cost of the Temane Regional Electricity Project (TREP) and intends to apply part of the proceeds toward payments under the contracts for: The construction of 11 Model houses and 137 Resettlement houses and Associated Social and Urban Infrastructure to be constructed under the Resettlement Action Programme (RAP) for the Temane Transmission Project (TTP).
2. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
3. Sociedade Nacional de Transporte de Energia (SNTE) now invites sealed Bids from eligible Bidders for:
 - a. Lot 1 - The construction of 6 Model houses and 36 Resettlement houses in the Districts of Funhalouro, Panda, Chibuto, Mandlakaze, Chokwe and Bilene. The contract must be completed within 231 days.
 - b. Lot 2 - The construction of 3 Model houses and 28 Resettlement houses in the Districts of Magude, Manhica and Marracuene together with the provision of village infrastructure for a single Resettlement village for 23 of the 31 houses in the District of Marracuene. The contract must be completed within 259 days.
 - c. Lot 3 - The construction of 1 Model house and 37 Resettlement houses in the District of Moamba. The contract must be completed within 259 days.
 - d. Lot 4 - The construction of 1 Model house and 36 Resettlement houses to be located in one resettlement village in the District of Boane together with the provision of village infrastructure. The contract must be completed within 259 days.
4. No margin of preference will be given.
5. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July 2016, Revised November 2017 and August 2018 ("Procurement Regulations") and is open to all eligible Bidders as defined in the Procurement Regulations.
