CONSULTING SERVICES Expressions of Interest

Electricidade de Moçambique, E.P. (EDM) has received funding from the Swedish International Development Cooperation Agency (SIDA) and intends to use part of the funds thereof for payments under the following Projects:

LOT1: Feasibility Study for Nampula - Angoche 110 kV OH Line; and

LOT2: Feasibility Study for Reconstruction of 110 kV OHL including River Crossing; 110 kV / 33 kV Substation; and 33 kV Distribution Lines in the North of Cabo Delgado Province.

This request for Expression of Interest seeks to recruit two Consulting Companies, i.e., one Company for each of the above-mentioned Lots. The main objective of the Feasibility Studies is to prepare an independent bankable feasibility reports, including the necessary integration with the existing network in the respective areas, demonstrating an effective cost solution.

The bankable Feasibility Studies will be capable of being used as the basis for EDM to seek financing from international development financing agencies to implement the recommended grid expansion and strengthening proiects.

Electricidade de Moçambique, E.P. (EDM) hereby invites Applicants to express their interest in delivering the Services described above.

This request for Expressions of Interest is open to Consulting Companies.

The Applicant should submit only one application, either in its name or as a member of a Joint Venture (JV). If an Applicant (including any JV member) submits or participates in more than one application, those applications shall be all rejected. However, the same Subconsultant may participate in several applications.

If the Applicant is a JV, the Expression of Interest should include:

A copy of the JV Agreement entered into by all members;

Of

 A letter of intent to execute a JV Agreement, signed by all members together with a copy of the Agreement proposal.

However, in the absence of this document, the other members will be considered as Subconsultants.

Hence, the experiences and qualifications of Subconsultants will not be taken into consideration in the evaluation of the applications.

Interested Applicants must provide information evidencing that they are qualified and experienced to perform the requested Services. For that purpose, documented evidence of recent and similar services should be submitted.

Qualification requirements of the Consulting Company:

- At least 3 similar Feasibility Studies performed in the last 5 years for an Electricity Public Utility; and
- Experience from Sub-Saharan African Countries in the last 5 years.

The Consultant's EOI application which meets the qualification requirements will be ranked based on the following Ranking Criteria:

Note: If there is a corruption case being filed to Court against the Natural Person or Board of Director of the Firm/ Institution/ Company or any partner of the JV, such Natural Person or Board of Director of the Firm/ Institution/ Company or any partner of the JV EOI shall be excluded from the evaluation.

An application that does not meet any of these requirements will be rejected.

Among the submitted applications, Electricidade de Moçambique, E.P. (EDM) will shortlist a maximum of six (6) Applicants for each Lot that have reached a minimum of 70 points, to whom the Request for Proposals to carry out the Services shall be sent.
