Eni Rovuma Basin B.V., Mozambique Branch, on behalf of Eni Mozambico S.p.A, invites interested companies to submit their Expression of Interest for the Provision of Liner Hanger & Related Services to support operations in Area AS-A in Mozambique.

SCOPE OF WORK

The scope of work consists of provision of Liner Hanger & Related Services as detailed below in order to perform the drilling activities to the deep water exploration well:

- Expandable liner hanger as per following diameters:
 - > 2 off 9 5/8" 53.5# P110 x 13 3/8" 72# P110:
 - 2 off 7" 32# P110 x 9 5/8" 53,5# P110;
- Services required:
 - 2 set off Rental equipment (tools for running tools, pulling, testing, redressing and any relevant tools);
 - Personnel well site assistance;
 - > Packing, offshore skids, shipping;
- Dedicated logistic base in Pemba surroundings, embarkation point for the equipment will be Pemba Port;
- Administrative & Operative Management based in Maputo;
- Company's registration in Mozambique;

The contract foresees a firm period needed to perform drilling and abandon activities on one (1) well.

The expected spud-in date is in Q1- 2022.

DOCUMENTATION REQUIRED

- Provide any relevant references for the previously executed projects of similar technical characteristics and magnitude;

- Provide Quality Management System certifications and/or certificates proving compliance with international Quality Standards (ISO 9001:2008);
- d) Provide Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided;
- e) Provide any other information that will establish ability of fulfilling this scope of work.

I. Administrative documents:

- Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from the Company;
- b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company's Group (if applicable), and also for the Company's Mozambican
